## A BILL

To require the National Institute of Minority Health and Health Disparities to submit to Congress a report on the impact of the opioid epidemic on minority communities.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Opioid Minority Health  
5 Report to Congress Act of 2018”.

1     **SEC. 2. NATIONAL INSTITUTE OF MINORITY HEALTH AND**  
2                 **HEALTH DISPARITIES REPORT ON THE IM-**  
3                 **PACT OF THE OPIOID EPIDEMIC ON MINOR-**  
4                 **ITY COMMUNITIES.**

5         Not later than one year after the date of the enact-  
6     ment of this Act, and annually thereafter, the National  
7     Institute of Minority Health and Health Disparities shall  
8     submit to the Committee on Finance of the Senate and  
9     the Committees on Ways and Means and Energy and  
10   Commerce of the House of Representatives, and make  
11   public on the Internet website of Department of Health  
12   and Human Services, a report on the impact of the opioid  
13   epidemic on racial and ethnic minority groups (as defined  
14   in section 1707(g) of the Public Health Service Act (42  
15   U.S.C. 300u–6(g))), including the following:

16                 (1) The scope of the epidemic within such racial  
17     and ethnic minority groups with respect to the use  
18     of prescription pain killers and illicit drug use, in-  
19     cluding synthetics.

20                 (2) The extent to which, and funding rec-  
21     ommendations for how, the expansion of coverage  
22     under the Medicare program under title XVIII of  
23     the Social Security Act and the Medicaid program  
24     under title XIX of such Act of medication-assisted  
25     treatment and other treatment options could de-

1       crease the incidence of opioids use and of deaths  
2       caused by opioids overdoses.

3           (3) The role of participation of such racial and  
4       minority groups in clinical trials for pain manage-  
5       ment therapy and alternatives to opioids pain man-  
6       agement and recommendations on how to increase  
7       such participation of such groups in such clinical  
8       trials.
