A BILL

To amend title XVIII of the Social Security Act to require prescription drug plans under Medicare part D to include information on the adverse effects of opioid overutilization and of coverage of nonpharmacological therapies and nonopioid medications or devices used to treat pain.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicare Clear Health
 5 Options in Care for Enrollees Act of 2018” or the “Medi-
 6 care CHOICE Act of 2018”.

7 **SEC. 2. REQUIRING MEDICARE PART D PRESCRIPTION**
 8 **DRUG PLANS TO INCLUDE INFORMATION ON**
 9 **ADVERSE EFFECTS RELATING TO OPIOIDS**
 10 **AND COVERAGE OF NONPHARMACOLOGICAL**
 11 **THERAPIES AND NONOPIOID MEDICATIONS**
 12 **OR DEVICES USED TO TREAT PAIN.**

13 Section 1860D–4(a)(1) of the Social Security Act (42
 14 U.S.C. 1395w–104(a)(1)) is amended—

15 (1) in subparagraph (A), by inserting “, subject
 16 to subparagraph (C),” before “including”;

17 (2) in subparagraph (B), by adding at the end
 18 the following new clause:

19 “(vi) For plan year 2021 and each
 20 subsequent plan year, subject to subpara-
 21 graph (C), with respect to the treatment of
 22 pain—

23 “(I) the adverse effects of pro-
 24 longed opioid use; and

1 “(II) coverage of nonpharma-
2 cological therapies, devices, and
3 nonopioid medications—

4 “(aa) in the case of an MA-
5 PD plan under part C, under
6 such plan; and

7 “(bb) in the case of a pre-
8 scription drug plan under such
9 plan and under parts A and B.”;
10 and

11 (3) by adding at the end the following new sub-
12 paragraph:

13 “(C) TARGETED PROVISION OF INFORMA-
14 TION.—A PDP sponsor of a prescription drug
15 plan may, in lieu of disclosing the information
16 described in subparagraph (B)(vi) to each en-
17 rollee under the plan, disclose such information
18 through mail or electronic communications to a
19 subset of enrollees under the plan, such as en-
20 rollees who have been prescribed an opioid in
21 the previous two-year period.”.
