3 (a) ADDITIONAL CONSIDERATIONS.—Section 2200c 4 of title 10, United States Code, is amended— 5 (1) by inserting before "In the selection" the 6 following: 7 "(a) CENTERS OF ACADEMIC EXCELLENCE IN CYBER EDUCATION.—"; and 8 9 (2) by adding at the end the following new sub-10 section: 11 "(b) CERTAIN INSTITUTIONS OF HIGHER EDU-CATION.—In the selection of a recipient for the award of 12 a scholarship or grant under this chapter, consideration 13 14 shall be given to whether— "(1) in the case of a scholarship, the institution 15 16 of higher education at which the recipient pursues a 17 degree is an institution described in section 371(a)18 of the Higher Education Act of 1965 (20 U.S.C. 19 1067q(a); and "(2) in the case of a grant, the recipient is an 20 21 institution described in such section.". 22 (b) CLERICAL AMENDMENTS.— 23 (1) SECTION HEADING.—The heading of section 24 2200c of title 10, United States Code, is amended 25 to read as follows: •HR 5746 IH
