Ms. WILSON of Florida (for herself, Mr. HASTINGS, and Ms. FRANKEL of Florida) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To amend the Public Health Service Act to authorize the Secretary of Health and Human Services to award grants to nursing homes, assisted living facilities, and other long-term care facilities to improve their preparedness for power outages.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disaster Preparedness
5 for Power Outages Act of 2018”.

1 **SEC. 2. IMPROVING THE PREPAREDNESS OF NURSING**
2 **HOMES, ASSISTED LIVING FACILITIES, AND**
3 **OTHER LONG-TERM CARE FACILITIES FOR**
4 **POWER OUTAGES.**

5 The Public Health Service Act is amended by insert-
6 ing after section 319C–2 of such Act (42 U.S.C. 247d–
7 3b) the following new section:

8 **“SEC. 319C–3. IMPROVING THE PREPAREDNESS OF NURS-**
9 **ING HOMES, ASSISTED LIVING FACILITIES,**
10 **AND OTHER LONG-TERM CARE FACILITIES**
11 **FOR POWER OUTAGES.**

12 “(a) GRANTS.—The Secretary may award grants to
13 nursing homes, assisted living facilities, and other long-
14 term care facilities to improve their preparedness for
15 power outages, including during and after a natural dis-
16 aster.

17 “(b) USE OF FUNDS.—The preparedness activities
18 funded through a grant under this section may include—

19 “(1) the purchase of a backup power source,
20 such as a generator, and any related equipment; and

21 “(2) the creation of a regional resource direc-
22 tory on disaster and post-disaster preparedness for
23 power outages.

24 “(c) PREFERENCE.—In awarding grants under this
25 section, the Secretary shall give preference to nursing

1 homes, assisted living facilities, and other long-term care
2 facilities that—

3 “(1) are located in areas that—

4 “(A) have a high proportion of—

5 “(i) elderly residents; or

6 “(ii) individuals who are enrolled in a
7 State plan under title XIX of the Social
8 Security Act (42 U.S.C. 1396 et seq.) (or
9 under a waiver of such plan); and

10 “(B) have a high risk of hurricanes or
11 other natural disasters; and

12 “(2) have not been cited for a substantive Fed-
13 eral, State, or local violation.

14 “(d) AUTHORIZATION OF APPROPRIATIONS.—To
15 carry out this section, there are authorized to be appro-
16 priated such sums as may be necessary.”.
