# **A BILL**

To amend the Endangered Species Act of 1973 to provide for consideration of the totality of conservation measures in determining the impact of proposed Federal agency action.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Weigh Habitats Offset-

5 ting Locational Effects Act of 2018” or the “WHOLE Act

6 of 2018”.

7 **SEC. 2. CONSIDERATION OF THE TOTALITY OF CONSERVA-**  
8 **TION MEASURES.**

9       Section 7(b)(3) of the Endangered Species Act of

10 1973 (16 U.S.C. 1536(b)(3)) is amended by adding at the

11 end the following:

12       “(C) In determining whether a Federal agency action

13 is likely to jeopardize the continued existence of any en-

14 dangered species or threatened species or result in the de-

15 struction or adverse modification of the critical habitat of

16 a species, the Secretary shall consider the offsetting ef-

17 fects of all avoidance, minimization, and other species-pro-

18 tection or conservation measures that are already in place

19 or proposed to be implemented as part of the action, in-

20 cluding the development, improvement, protection, or

21 management of species habitat whether or not it is des-

22 ignated as critical habitat of such species.”.
