Mr. CONNOLLY introduced the following bill; which was referred to the Committee on Energy and Commerce, and in addition to the Committees on Transportation and Infrastructure, Agriculture, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To suspend proposed rulemaking signed by former Administrator of the Environmental Protection Agency Scott Pruitt, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ensuring Scott Pruitt
5 is Accountable Act of 2018” or the “EPA Act of 2018”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

1 (1) on August 28, 2017, the Office of Inspector
2 General of the Environmental Protection Agency (re-
3 ferred to in this Act as the “EPA OIG”) announced
4 that it would conduct an audit of Scott Pruitt, then-
5 Administrator of the Environmental Protection
6 Agency (referred to in this Act as the “Agency”),
7 for—

8 (A) the unprecedented and frequent travel
9 expenses incurred by Mr. Pruitt for travel to
10 his home State of Oklahoma; and

11 (B) the reliance by Mr. Pruitt on first-
12 class seats on commercial airplanes;

13 (2) on December 6, 2017, the EPA OIG an-
14 nounced that it would review whether Mr. Pruitt or
15 his staff violated Federal lobbying laws during a
16 meeting in April 2017 with the National Mining As-
17 sociation, during which meeting it was reported that
18 Mr. Pruitt advised the Association to encourage
19 President Trump to withdraw from the Paris Cli-
20 mate Agreement;

21 (3) on December 8, 2017, the EPA OIG opened
22 a review into the manner in which the Agency de-
23 cided to spend more than \$25,000 to install a secure
24 soundproof communications booth in the office of
25 Mr. Pruitt;

1 (4) on January 8, 2018, the EPA OIG began
2 an audit on the exploitation of the Safe Drinking
3 Water Act (42 U.S.C. 300f et seq.) by Mr. Pruitt
4 to give pay raises to 2 top aides, even after the
5 Trump administration refused the request for those
6 pay raises;

7 (5) on April 17, 2018, the EPA OIG opened an
8 investigation into the use of a security detail by Mr.
9 Pruitt during personal trips to Disneyland and the
10 Rose Bowl;

11 (6) on April 19, 2018, the EPA OIG confirmed
12 a probe into a request from Mr. Pruitt for around-
13 the-clock security protection;

14 (7) on April 25, 2018, the EPA OIG agreed to
15 examine the use by Mr. Pruitt of Agency staff for
16 personal errands, including—

17 (A) inquiring about purchasing a used
18 mattress from the Trump International Hotel;

19 (B) locating a particular lotion from the
20 Ritz-Carlton Hotels; and

21 (C) seeking a Chick-fil-A franchise for his
22 wife;

23 (8) on April 27, 2018, the EPA OIG opened a
24 review into the rental by Mr. Pruitt of a bedroom in
25 Capitol Hill, Washington, DC, from an energy in-

1 industry lobbyist for \$50 per night, a rate that is well
2 below market value; and

3 (9) on May 15, 2018, the EPA OIG announced
4 that it would look into the use of multiple email ad-
5 dresses by Mr. Pruitt as potential violations of chap-
6 ter 31 of title 44, United States Code, relating to
7 records management by Federal agencies, and of the
8 records management policy of the Agency.

9 **SEC. 3. SUSPENSION OF PROPOSED RULEMAKING BY PRU-**
10 **ITT.**

11 (a) IN GENERAL.—The Administrator of the Agency
12 shall not finalize or engage in any rulemaking with respect
13 to a rule for which the advance notice of proposed rule-
14 making or the notice of proposed rulemaking was signed
15 by Scott Pruitt until the date on which the report de-
16 scribed in subsection (b) becomes publicly available.

17 (b) REPORT.—On completion of the audits, reviews,
18 investigations, and probe described in section 2, the In-
19 spector General of the EPA OIG shall make publicly avail-
20 able a report that describes the findings and conclusions
21 of each audit, review, investigation, and probe.
