## A BILL

To provide for the unencumbering of title to non-Federal land owned by Embry-Riddle Aeronautical University, Florida, for purposes of economic development by conveyance of the Federal reversionary interest to the University.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Embry-Riddle Tri-City  
5       Land Exchange Completion Act”.

6       **SEC. 2. DEFINITIONS.**

7       In this Act:

1                             (1) UNIVERSITY.—The term “University”  
2     means Embry-Riddle Aeronautical University, Flor-  
3     ida.

4                             (2) NON-FEDERAL LAND.—The term “non-Fed-  
5     eral land” means the approximately 16-acre parcel  
6     of University land identified in section 3(a) of Public  
7     Law 105–363.

8                             (3) SECRETARY.—The term “Secretary” means  
9     the Secretary of the Interior.

10 **SEC. 3. CONVEYANCE OF FEDERAL REVERSIONARY INTER-**  
11                             **EST IN LAND LOCATED IN THE COUNTY OF**  
12                             **YAVAPAI, ARIZONA.**

13                             (a) IN GENERAL.—Notwithstanding any other provi-  
14     sion of law, the Secretary shall convey to the University,  
15     without consideration, the reversionary interests of the  
16     United States in and to the non-Federal land for the pur-  
17     pose of unencumbering the title to the non-Federal land  
18     to enable economic development of the non-Federal land.

19                             (b) LEGAL DESCRIPTIONS.—As soon as practicable  
20     after the date of enactment of this Act, the exact legal  
21     description of the non-Federal land shall be determined  
22     in a manner satisfactory to the Secretary.

23                             (c) ADDITIONAL TERMS AND CONDITIONS.—The  
24     Secretary may require such additional terms and condi-  
25     tions to the conveyance under subsection (a), consistent

1 with that subsection, as the Secretary considers appro-  
2 priate to protect the interests of the United States.

3 (d) COSTS.—The University shall pay all costs associ-  
4 ated with the conveyance under subsection (a), consistent  
5 with that subsection, including the costs of any surveys,  
6 recording costs, and other reasonable costs.
