A BILL

To extend certain authorities relating to United States efforts to combat HIV/AIDS, tuberculosis, and malaria globally, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “PEPFAR and Protec-
5 tions for Orphans and Vulnerable Children Act of 2018”.

6 **SEC. 2. INSPECTORS GENERAL AND ANNUAL STUDY.**

7 Section 101 of the United States Leadership Against
8 HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22
9 U.S.C. 7611) is amended—

10 (1) in subsection (f)(1)—

1 (A) in subparagraph (A), by striking
2 “2018” and inserting “2023”; and

3 (B) in subparagraph (C)(iv)—

4 (i) by striking “four” and inserting
5 “nine”; and

6 (ii) by striking “2018” and inserting
7 “2023”; and

8 (2) in subsection (g)—

9 (A) in paragraph (1), by striking “2019”
10 and inserting “2024”; and

11 (B) in paragraph (2)—

12 (i) in the heading, by striking “2018”
13 and inserting “2024”; and

14 (ii) by striking “September 30, 2018”
15 and inserting “September 30, 2023”.

16 **SEC. 3. PARTICIPATION IN THE GLOBAL FUND TO FIGHT**
17 **AIDS, TUBERCULOSIS, AND MALARIA.**

18 Section 202(d) of the United States Leadership
19 Against HIV/AIDS, Tuberculosis, and Malaria Act of
20 2003 (22 U.S.C. 7622(d)) is amended—

21 (1) in paragraph (4)—

22 (A) in subparagraph (A)—

23 (i) in clause (i), by striking “fiscal
24 years 2009 through 2018” and inserting
25 “fiscal years 2004 through 2023”;

1 (ii) in clause (ii), by striking “2018”
2 and inserting “2023”; and
3 (iii) by striking clause (vi); and
4 (B) in subparagraph (B)—
5 (i) by striking clause (ii);
6 (ii) by redesignating clauses (iii) and
7 (iv) as clauses (ii) and (iii), respectively;
8 (iii) in clause (ii) (as redesignated by
9 clause (ii) of this subparagraph)—
10 (I) in the first sentence, by add-
11 ing at the end before the period the
12 following: “or section 104B or 104C
13 of such Act”; and
14 (II) in the second sentence, by
15 striking “for HIV/AIDS assistance”;
16 and
17 (iv) in clause (iii) (as redesignated by
18 clause (ii) of this subparagraph), by strik-
19 ing “2018” and inserting “2023”; and
20 (2) in paragraph (5), by striking “2018” and
21 inserting “2023”.

22 **SEC. 4. ALLOCATION OF FUNDS.**

23 Section 403 of the United States Leadership Against
24 HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22
25 U.S.C. 7673) is amended—

- 1 (1) in subsection (b), by striking “2018” and
2 inserting “2023”; and
- 3 (2) in subsection (c), by striking “2018” and
4 inserting “2023”.
