3 SECTION 1. IMPROVEMENTS TO HOME HEALTH PAYMENT

5 (a) APPLICATION OF BUDGET NEUTRALITY.—Sec6 tion 1895(b)(3) of the Social Security Act (42 U.S.C.
7 1395fff(b)(3)), as amended by section 51001(a)(2) of the

1	Bipartisan Budget Act of 2018 (Public Law 115–123),
2	is amended—
3	(1) in subparagraph (A)(iv), in the fourth sen-
4	tence—
5	(A) by striking "shall make" and inserting
6	"shall not make"; and
7	(B) by striking "and shall provide a de-
8	scription" and all that follows through the pe-
9	riod and inserting a period;
10	(2) in subparagraph (D)—
11	(A) in the subparagraph heading, by strik-
12	ing "ASSUMPTIONS" and inserting "OBSERVED
13	EVIDENCE";
14	(B) in clause (i)—
15	(i) by striking "differences between
16	assumed" and all that follows through
17	"and actual";
18	(ii) by inserting "attributable to the
19	implementation of paragraphs $(2)(B)$ and
20	(4)(B)" after "behavior changes"; and
21	(iii) by adding at the end the fol-
22	lowing: "The Secretary shall publish the
23	determination under this clause with re-
24	spect to an applicable year, including a de-
25	scription of the observed evidence used to

1	make such determination, in the notice and
2	comment rulemaking to update the pro-
3	spective payment system under this sub-
4	section for such year. For purposes of the
5	preceding sentence, the term 'observed evi-
6	dence' means statistically valid data from
7	the most recent cost report and claims re-
8	garding changes in the nature of home
9	health agency patients, patterns of care,
10	service costs, and claims coding after Jan-
11	uary 1, 2020, reflecting behavioral changes
12	relating to implementation of the provi-
13	sions of and amendments made by section
14	51001 of the Bipartisan Budget Act of
15	2018 (Public Law 115–123).";
16	(C) in clause (ii), by inserting "attrib-
17	utable to the implementation of paragraphs
18	(2)(B) and $(4)(B)$ " after "expenditures"; and
19	(D) in clause (iii)—
20	(i) by adding "attributable to the im-
21	plementation of paragraphs $(2)(B)$ and
22	(4)(B)" after "expenditures"; and
23	(ii) by adding at the end the fol-
24	lowing: "If such a temporary increase or
25	decrease does not exceed 2.00 percent in

1 any given year, the Secretary shall apply 2 the entire increase or decrease in the next 3 calendar year payment update; however, if 4 such a temporary increase or decrease ex-5 ceeds 2.00, to provide for minimal disruption to patients and providers, the Sec-6 7 retary shall phase in the temporary increase or decrease in equal amounts not to 8 9 exceed 2.00 percent in any given year through the respective calendar year pay-10 11 ment updates.". 12 (b) EFFECTIVE DATE.—The amendments made by this section shall take effect as if included in the enact-13

14 ment of such section 51001(a)(2).
