Mr. BISHOP of Utah introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To direct the Secretary of the Interior to convey certain Bureau of Land Management land in Daggett County, Utah, to the State of Utah for public purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Jarvie Ranch Convey-
5 ance Act”.

6 **SEC. 2. DEFINITIONS.**

7 For the purposes of this Act:

8 (1) STATE.—The term “State” means the State
9 of Utah.

1 (2) SECRETARY.—The term “Secretary” means
2 the Secretary of the Interior.

3 **SEC. 3. LAND CONVEYANCE, STATE OF UTAH.**

4 (a) CONVEYANCE REQUIRED.—Subject to valid exist-
5 ing rights, if the State submits a written request to the
6 Secretary not later than 90 days after the date of enact-
7 ment of this Act requesting the conveyance of the Bureau
8 of Land Management land described in subsection (b) for
9 public purposes, the Secretary shall convey, without con-
10 sideration and by quitclaim deed, to the State all right,
11 title, and interest of the United States in and to the parcel
12 of land, including improvements thereon, described in sub-
13 section (b).

14 (b) DESCRIPTION OF LAND.—

15 (1) IN GENERAL.—The parcel of Bureau of
16 Land Management land and any improvements to be
17 conveyed under subsection (a) is the approximately
18 530-acre parcel identified on the map entitled
19 “Jarvie Ranch Conveyance Act”, and dated ____.

20 (2) AVAILABILITY OF MAP.—The map referred
21 to in paragraph (1) shall be kept on file and avail-
22 able for public inspection in the appropriate office of
23 the Bureau of Land Management. The Secretary
24 may correct minor errors in the map.

1 (c) SURVEY.—The exact acreage and legal descrip-
2 tion of the Bureau of Land Management land to be con-
3 veyed under subsection (a) shall be determined by a survey
4 satisfactory to the Secretary.

5 (d) TIME FOR COMPLETION OF CONVEYANCE.—The
6 Secretary shall complete the conveyance under subsection
7 (a) not later than one year after the date on which the
8 State submits the written request described in such sub-
9 section.
