Mr. FITZPATRICK introduced the following bill; which was referred to the
Committee on Oversight and Government Reform

A BILL

To prohibit immediate family members of heads of certain agencies and departments from soliciting or otherwise raising funds from certain foreign entities.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cabinet Service Integ-

5 rity Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) CLOSE ASSOCIATE.—The term “close asso-

9 ciate” means, with respect to a senior foreign polit-

1 ical figure, an individual who is widely and publicly
2 known to maintain a close relationship with the sen-
3 ior foreign political figure, unless it is established
4 that such individual is a citizen of and domiciled
5 within the United States.

6 (2) COVERED FOREIGN ENTITY.—The term
7 “covered foreign entity” means—

8 (A) a government of a foreign country;

9 (B) a foreign political party; or

10 (C) any entity that is owned or controlled
11 by a government of a foreign country or a for-
12 eign political party.

13 (3) FOREIGN POLITICAL PARTY; GOVERNMENT
14 OF A FOREIGN COUNTRY.—The terms “foreign polit-
15 ical party” and “government of a foreign country”
16 have the meanings given those terms in section 1 of
17 the Foreign Agents Registration Act of 1938 (22
18 U.S.C. 611).

19 (4) IMMEDIATE FAMILY MEMBER OF A HEAD
20 OF A RELEVANT AGENCY OR DEPARTMENT.—The
21 term “immediate family member of a head of a rel-
22 evant agency or department” means, with respect to
23 a head of a relevant agency or department, a sibling,
24 spouse, or child of the head of a relevant agency or
25 department.

1 (5) IMMEDIATE FAMILY MEMBER OF A SENIOR
 2 FOREIGN POLITICAL FIGURE.—The term “immediate
 3 family member of a senior foreign political figure”
 4 means, with respect to a senior foreign political fig-
 5 ure, a sibling, spouse, or child of the senior foreign
 6 political figure, unless it is established that such sib-
 7 ling, spouse, or child is a citizen of and domiciled
 8 within the United States.

9 (6) RELEVANT AGENCY OR DEPARTMENT.—The
 10 term “relevant agency or department” means—

11 (A) the Environmental Protection Agency;

12 or

13 (B) an “Executive department”, as defined
 14 in section 101 of title 5, United States Code.

15 (7) SENIOR FOREIGN POLITICAL FIGURE.—The
 16 term “senior foreign political figure” means—

17 (A) a senior official in any branch of the
 18 government of a foreign country; or

19 (B) a senior official of a foreign political
 20 party.

21 **SEC. 3. PROHIBITION.**

22 During the period in which an individual is acting
 23 as the head of a relevant agency or department, an imme-
 24 diate family member of that head of a relevant agency or

1 department may not solicit or otherwise raise funds for
2 any purpose from any—

3 (1) covered foreign entity;

4 (2) senior foreign political figure;

5 (3) immediate family member of a senior for-
6 eign political figure;

7 (4) close associate of a senior foreign political
8 figure; or

9 (5) entity that is owned or controlled by an in-
10 dividual described in paragraph (2), (3), or (4).

11 **SEC. 4. PENALTIES.**

12 Whoever knowingly fails to comply with this Act shall
13 be fined not more than \$1,000,000, imprisoned not more
14 than 5 years, or both.

15 **SEC. 5. EFFECTIVE DATE.**

16 This Act shall take effect on the date that is 30 days
17 after the date of enactment of this Act.
