## A BILL

To replace references to “wives” and “husbands” in Federal law with references to “spouses”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Amend the Code for  
5       Marriage Equality Act of 2017”.

6       **SEC. 2. AMENDMENTS.**

7       (a) ACT OF AUGUST 16, 1941.—Section 2(b) of the  
8       Act of August 16, 1941, entitled “An Act to provide com-  
9       pensation for disability or death to persons employed at  
10      military, air, and naval bases outside the United States.”

1 (42 U.S.C. 1652(b)) is amended by striking “wife” each  
2 place such term appears and inserting “spouse”.

3 (b) ACT OF AUGUST 4, 1955.—Section 43(a) of the  
4 Act of August 4, 1955, entitled “An Act to direct the Sec-
