Mr. BROWN (for himself and Mr. CASEY) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

## A BILL

To require the Attorney General to designate Human Trafficking Coordinators for Federal judicial districts, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. HUMAN TRAFFICKING COORDINATORS.**

4       Section 606 of the Justice for Victims of Trafficking  
5       Act of 2015 (42 U.S.C. 14044h) is amended—

6               (1) in subsection (b)(1)—

7                       (A) by striking subparagraph (B); and

8                       (B) by redesignating subparagraphs (C)

9                       and (D) as subparagraphs (B) and (C), respec-

10                      tively; and

1 (2) by adding at the end the following:

2 “(c) HUMAN TRAFFICKING JUSTICE COORDINA-  
3 TORS.—The Attorney General shall designate in each Fed-  
4 eral judicial district not less than 1 Assistant United  
5 States Attorney to serve as the Human Trafficking Coor-  
6 dinator for the district, who, in addition to any other re-  
7 sponsibilities, shall be responsible for—

8 “(1) implementing the National Strategy with  
9 respect to all forms of human trafficking, including  
10 labor trafficking and sex trafficking;

11 “(2) prosecuting or assisting in the prosecution  
12 of human trafficking cases;

13 “(3) conducting public outreach and awareness  
14 activities relating to human trafficking;

15 “(4) ensuring the collection of data related to  
16 human trafficking required by law to be collected;

17 “(5) coordinating with other Federal agencies,  
18 State, Tribal, and local law enforcement agencies,  
19 and victim service providers to build partnerships on  
20 activities relating to human trafficking; and

21 “(6) take appropriate steps and, when nec-  
22 essary, legal action to collect restitution for victims  
23 as required to be ordered under section 1593 of title  
24 18, United States Code, or under any other restitu-

1       tion order issued by a Federal court to be paid to  
2       a victim in a human trafficking case.

3       “(d) DEPARTMENT OF JUSTICE COORDINATOR.—

4 Not later than 60 days after the date of enactment of this  
5 subsection, the Attorney General shall designate a Deputy  
6 Assistant Attorney General who is a career appointee (as  
7 that term is defined in section 3132(a) of title 5, United  
8 States Code) as the National Human Trafficking Coordi-  
9 nator within the Department of Justice, who, in addition  
10 to any other responsibilities, shall be responsible for—

11           “(1) coordinating, promoting, and supporting  
12       the work of the Department of Justice relating to  
13       human trafficking, including investigation, prosecu-  
14       tion, training, outreach, victim support, grant-mak-  
15       ing, and policy activities;

16           “(2) reviewing data collected by Human Traf-  
17       ficking Justice Coordinators in the Federal judicial  
18       districts and, when necessary, communicating with  
19       the Coordinators to discuss such data;

20           “(3) making recommendations to the Deputy  
21       Attorney General on where resources should be allo-  
22       cated to combat human trafficking;

23           “(4) in consultation with survivors of human  
24       trafficking, or anti-human trafficking organizations,  
25       producing, and disseminating, including making

1 publicly available, when possible, replication guides  
2 and training materials for law enforcement officers,  
3 prosecutors, judges, emergency responders, individ-  
4 uals working in crime victim services, schools and  
5 school systems, adult and child protective services,  
6 social services, and public safety, medical personnel,  
7 mental health personnel, financial services personnel,  
8 and any other individuals whose work may bring  
9 them in contact with human trafficking regarding  
10 how to—

11 “(A) identify signs of human trafficking;

12 “(B) conduct investigations in human traf-  
13 ficking cases;

14 “(C) address evidentiary issues and other  
15 legal issues in human trafficking cases; and

16 “(D) appropriately assess, respond to, and  
17 interact with victims and witnesses in human  
18 trafficking cases, including in administrative,  
19 civil, and criminal judicial proceedings; and

20 “(5) carrying out such other duties as the At-  
21 torney General determines necessary in connection  
22 with enhancing the understanding, prevention, detec-  
23 tion, investigation, and prosecution of, and response  
24 to, human trafficking.”.
