A BILL

To amend the Small Business Act to establish awareness of, and technical assistance for, the creation of employee stock ownership plans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Em-
5 ployee Ownership Promotion Enhancement Act of 2017”.

1 **SEC. 2. SCORE PROGRAM ASSISTANCE.**

2 Section 8(b)(1)(B) of the Small Business Act (15
3 U.S.C. 637(b)(1)(B)) is amended—

4 (1) by inserting “(i)” after “(B)”;

5 (2) in clause (i), as so designated, in the first
6 sentence, by striking “(SCORE)” and inserting
7 “(referred to in this subparagraph as ‘SCORE’)”;
8 and

9 (3) by adding at the end the following:

10 “(ii) SCORE shall appoint an individual to
11 serve as the SCORE Employee Ownership Di-
12 rector—

13 “(I) whose duties shall relate to the
14 various forms of employee ownership;

15 “(II) who shall be responsible for—

16 “(aa) administering and dis-
17 bursing materials that contain general
18 information and technical assistance
19 with respect to the establishment of
20 employee ownership structures;

21 “(bb) coordinating efforts with
22 respect to employee ownership with
23 the chapters of SCORE located
24 throughout the United States;

25 “(cc) providing technical assist-
26 ance relating to a range of business

1 forms and strategies that promote or
 2 facilitate employee ownership, includ-
 3 ing—

4 “(AA) an employee stock
 5 ownership plan;

6 “(BB) a cooperative; and

7 “(CC) any other approach
 8 determined appropriate by the
 9 SCORE Employee Ownership Di-
 10 rector; and

11 “(dd) providing the Adminis-
 12 trator and the Office of Entrepre-
 13 neurial Development with statistics,
 14 including regional statistics from a
 15 chapter of SCORE, relating to serv-
 16 ices provided to small business con-
 17 cerns potentially undertaking a form
 18 of employee ownership; and

19 “(HH) who may be an employee of the
 20 Administration as of the date on which the
 21 appointment is made.”.

10 “(dd) *providing the Adminis-*
11 *trator and the Office of Entrepre-*
12 *neurial Development with statistics,*
13 *including regional statistics from a*
14 *chapter of SCORE, relating to services*
15 *provided to small business concerns po-*
16 *tentially undertaking a form of em-*
17 *ployee ownership; and*

18 “(III) *who may be an employee of*
19 *SCORE as of the date on which the ap-*
20 *pointment is made.”.*
