Mr. BLUMENTHAL introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

For the relief of Nury Chavarria.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR NURY**
4 **CHAVARRIA.**

5 (a) IN GENERAL.—Notwithstanding subsections (a)
6 and (b) of section 201 of the Immigration and Nationality
7 Act (8 U.S.C. 1151), Nury Chavarria shall be eligible for
8 issuance of an immigrant visa or for adjustment of status
9 to that of an alien lawfully admitted for permanent resi-
10 dence upon filing an application for issuance of an immi-
11 grant visa under section 204 of such Act (8 U.S.C. 1154)
12 or for adjustment of status to lawful permanent resident.

1 (b) ADJUSTMENT OF STATUS.—If Nury Chavarria
2 enters the United States before the filing deadline speci-
3 fied in subsection (c), Nury Chavarria shall be considered
4 to have entered and remained lawfully in the United
5 States and shall be eligible for adjustment of status under
6 section 245 of the Immigration and Nationality Act (8
7 U.S.C. 1255) as of the date of the enactment of this Act.

8 (c) APPLICATION AND PAYMENT OF FEES.—Sub-
9 sections (a) and (b) shall apply only if the application for
10 the issuance of an immigrant visa or the application for
11 adjustment of status is filed with appropriate fees not
12 later than 2 years after the date of the enactment of this
13 Act.

14 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—
15 Upon the granting of an immigrant visa or permanent res-
16 idence to Nury Chavarria, the Secretary of State shall in-
17 struct the proper officer to reduce by 1, during the current
18 or next following fiscal year—

19 (1) the total number of immigrant visas that
20 are made available to natives of the country of birth
21 of Nury Chavarria under section 203(a) of the Im-
22 migration and Nationality Act (8 U.S.C. 1153(a));
23 or

24 (2) if applicable, the total number of immigrant
25 visas that are made available to natives of the coun-

1 try of birth of Nury Chavarria under section 202(e)
2 of such Act (8 U.S.C. 1152(e)).

3 (e) PAYGO.—The budgetary effects of this Act, for
4 the purpose of complying with the Statutory Pay-As-You-
5 Go Act of 2010, shall be determined by reference to the
6 latest statement titled “Budgetary Effects of PAYGO
7 Legislation” for this Act, submitted for printing in the
8 Congressional Record by the Chairman of the Committee
9 on the Budget of the Senate, provided that such statement
10 has been submitted prior to the vote on passage.
