To modify the boundary of the Fort Scott National Historic Site in the State of Kansas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fort Scott National
5 Historic Site Boundary Modification Act”.

1 **SEC. 2. FORT SCOTT NATIONAL HISTORIC SITE.**

2 (a) IN GENERAL.—Public Law 95–484 (92 Stat.
3 1610) is amended—

4 (1) in the first section—

5 (A) by inserting “, by purchase from will-
6 ing sellers with donated or appropriated funds,
7 or by exchange” after “donation”; and

8 (B) by striking “Kansas: *Provided*” and all
9 that follows through the period and inserting
10 the following: “Kansas, and the land to be
11 added to the Fort Scott National Historic Site
12 under section 2(b).”; and

13 (2) in section 2—

14 (A) by striking “SEC. 2. When” and in-
15 serting the following:

16 **“SEC. 2. ESTABLISHMENT.**

17 **“(a) IN GENERAL.—When”; and**

18 **(B) by adding at the end the following:**

19 **“(b) BOUNDARY MODIFICATION.—The boundary of**
20 **the Fort Scott National Historic Site established under**
21 **subsection (a) is modified as generally depicted on the**
22 **map entitled ‘Fort Scott National Historic Site Proposed**
23 **Boundary Modification’, numbered 471/80,057, and dated**
24 **February 2016.”.**
