A BILL

To amend the Marine Mammal Protection Act of 1972 to protect the cultural practices and livelihoods of producers of Alaska Native handicrafts and traditional mammoth ivory products, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Allowing Alaska to
3 Improve Vital Opportunities in the Rural Economy Act”
4 or the “Allowing Alaska IVORY Act”.

5 **SEC. 2. ALASKA NATIVE HANDICRAFTS.**

6 Section 101(b) of the Marine Mammal Protection Act
7 of 1972 (16 U.S.C. 1371(b)) is amended—

8 (1) by striking paragraph (1) and all that fol-
9 lows through “is done” in the first sentence of para-
10 graph (2) and inserting the following:

11 “(A)(i) is for subsistence purposes; or
12 “(ii) is done”;

13 (2) by redesignating paragraph (3) as subpara-
14 graph (B); and indenting appropriately;

15 (3) in the matter preceding subparagraph (A)(i)
16 (as redesignated by paragraph (1)), by striking “(b)
17 Except as” and inserting the following:

18 “(b) APPLICATION TO CERTAIN ALASKA NATIVES.—

19 “(1) DEFINITIONS.—In this subsection:

20 “(A) AUTHENTIC NATIVE ARTICLE OF
21 HANDICRAFTS AND CLOTHING.—The term ‘au-
22 thentic native article of handicrafts and cloth-
23 ing’ means an item composed wholly or in some
24 significant respect of natural materials that is
25 produced, decorated, or fashioned in the exer-
26 cise of traditional native handicrafts without

1 the use of a pantograph, multiple carvers, or
2 any other mass copying device.

3 “(B) TRADITIONAL NATIVE HANDI-
4 CRAFTS.—The term ‘traditional native handi-
5 crafts’ includes weaving, carving, stitching, sew-
6 ing, lacing, beading, drawing, and painting.

7 “(2) APPLICATION.—Except as”;

8 (4) in subparagraph (A)(ii) of paragraph (2)
9 (as redesignated by paragraph (1)), by striking “and
10 clothing.” and all that follows through “painting”
11 and inserting “and clothing”;

12 (5) in the flush text following subparagraph (B)
13 of paragraph (2) (as redesignated by paragraph (2)),
14 by striking “Notwithstanding the preceding provi-
15 sions of this subsection, when” and inserting the fol-
16 lowing:

17 “(3) LIMITATIONS.—Notwithstanding para-
18 graph (2), if”;

19 and

20 (6) by adding at the end the following:

21 “(4) SPECIAL RULES.—

22 “(A) INTERSTATE COMMERCE.—Only au-
23 thentic native articles of handicrafts and cloth-
24 ing may be sold in interstate commerce.

1 “(B) EDIBLE PORTIONS OF MARINE MAM-
 2 MALS.—Any edible portion of a marine mammal
 3 may be sold in a native village or town in Alas-
 4 ka or for native consumption.

5 “(5) PROHIBITIONS.—

6 “(A) WALRUS IVORY OR WHALE BONE.—
 7 No State shall prohibit the importation, sale,
 8 offer for sale, transfer, trade, barter, possession
 9 or possession with the intent to sell, transfer,
 10 trade, or barter of walrus ivory or whale bone
 11 produced under this title by an Indian, Aleut,
 12 or Eskimo as an authentic native article of
 13 handicrafts and clothing.

14 “(B) MAMMOTH IVORY.—No State shall
 15 prohibit the importation, sale, offer for sale,
 16 transfer, trade, possession or possession with
 17 the intent to sell, transfer, trade, or barter of
 18 mammoth ivory or a mammoth ivory product.”.

19 **SECTION 1. SHORT TITLE.**

20 *This Act may be cited as the “Allowing Alaska to Im-*
 21 *prove Vital Opportunities in the Rural Economy Act” or*
 22 *the “Allowing Alaska IVORY Act”.*

23 **SEC. 2. ALASKA NATIVE HANDICRAFTS.**

12 “(b) *APPLICATION TO CERTAIN ALASKA NATIVES.—*

13 “(1) *DEFINITIONS.—In this subsection:*

14 “(A) *AUTHENTIC NATIVE ARTICLE OF*
 15 *HANDICRAFTS AND CLOTHING.—The term ‘au-*
 16 *thentic native article of handicrafts and clothing’*
 17 *means an item composed wholly or in some sig-*
 18 *nificant respect of natural materials that is pro-*
 19 *duced, decorated, or fashioned in the exercise of*
 20 *traditional native handicrafts without the use of*
 21 *a pantograph, multiple carvers, or any other*
 22 *mass copying device.*

23 “(B) *TRADITIONAL NATIVE HANDICRAFTS.—*

24 *The term ‘traditional native handicrafts’ in-*

1 *cludes weaving, carving, stitching, sewing, lac-*
 2 *ing, beading, drawing, and painting.*

3 “(2) *APPLICATION.—Except as*”;

4 (4) *in subparagraph (A)(ii) of paragraph (2) (as*
 5 *redesignated by paragraph (1)), by striking “and*
 6 *clothing:” and all that follows through “painting”*
 7 *and inserting “and clothing”;*

8 (5) *in the flush text following subparagraph (B)*
 9 *of paragraph (2) (as redesignated by paragraph (2)),*
 10 *by striking “Notwithstanding the preceding provi-*
 11 *sions of this subsection, when” and inserting the fol-*
 12 *lowing:*

13 “(3) *LIMITATIONS.—Notwithstanding paragraph*
 14 *(2), if*”; *and*

15 (6) *by adding at the end the following:*

16 “(4) *SPECIAL RULES.—*

17 “(A) *INTERSTATE COMMERCE.—Only au-*

 22 *may be sold in a native village or town in Alas-*
 23 *ka or for native consumption.*

24 “(5) *PROHIBITIONS.—No State or political sub-*
 25 *division thereof shall prohibit the importation, sale,*

1 *offer for sale, transfer, trade, barter, possession or pos-*
2 *session with the intent to sell, transfer, trade, or bar-*
3 *ter of mammoth, mastodon, or walrus ivory, marine*
4 *mammal bones, teeth, or baleen produced under this*
5 *title by an Indian, Aleut, or Eskimo as an authentic*
6 *native article of handicrafts and clothing.”.*
