Mr. WARNER (for himself, Mr. MANCHIN, Mrs. CAPITO, and Mr. Kaine) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To amend the Department of Agriculture Reorganization Act of 1994 to rename the Department of Agriculture.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Department of Agri-
5 culture and Rural Development Act of 2018”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

8 (1) the Department of Agriculture is the pri-
9 mary Federal agency dedicated to improving the

1 economy and quality of life in rural areas of the
2 United States;

3 (2) the Department of Agriculture provides significant financial resources and technical assistance
4 to rural communities, including loans, loan guarantees, and grants to help support economic development in rural areas of the United States;

5 (3) the United States has a substantial interest
6 in ensuring that the nearly 45,000,000 individuals in
7 the United States living in rural communities have
8 access to critical infrastructure, broadband, telecommunications connectivity, capital, health care,
9 and other essential resources; and

10 (4) renaming the Department of Agriculture
11 the “Department of Agriculture and Rural Development” would—

12 (A) further establish the importance of
13 rural development to the mission of the Department;
14 and

15 (B) raise awareness in rural areas of the
16 United States of the essential role the Department
17 has in supporting rural communities
18 throughout the United States.

1 **SEC. 3. DEPARTMENT OF AGRICULTURE AND RURAL DE-**
2 **VELOPMENT.**

3 (a) IN GENERAL.—Subtitle A of the Department of
4 Agriculture Reorganization Act of 1994 (7 U.S.C. 6901
5 et seq.) is amended by adding at the end the following:

6 **“SEC. 221. RENAMING AS DEPARTMENT OF AGRICULTURE**
7 **AND RURAL DEVELOPMENT.**

8 “(a) IN GENERAL.—

9 “(1) DEPARTMENT.—The Department of Agri-
10 culture shall be known and designated as the ‘De-
11 partment of Agriculture and Rural Development’.

12 “(2) SECRETARY.—The Secretary of Agri-
13 culture shall be known and designated as the ‘Sec-
14 retary of Agriculture and Rural Development’.

15 “(b) REFERENCES.—Except as provided in sub-
16 section (c), any reference to the Department of Agri-
17 culture or the Secretary of Agriculture in any law, regula-
18 tion, map, document, record, or other paper of the United
19 States shall be deemed to be a reference to the Depart-
20 ment of Agriculture and Rural Development and the Sec-
21 retary of Agriculture and Rural Development, respectively.

22 “(c) LIMITATION ON APPLICATION.—The renaming
23 of the Department of Agriculture and the Secretary of Ag-
24 riculture under this section shall not apply to any acro-
25 nyms used before the date of enactment of this section
26 by the Secretary for the purposes of labeling.”.

1 (b) AUTHORITY.—Section 296(b) of the Department
2 of Agriculture Reorganization Act of 1994 (7 U.S.C.
3 7014(b)) is amended by adding at the end the following:
4 “(9) The authority of the Secretary to carry out
5 section 221.”.
