## A BILL

To amend the Public Health Service Act to improve essential oral health care for low-income and other underserved individuals by breaking down barriers to care, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1   **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Action for Dental  
3   Health Act of 2018”.

4   **SEC. 2. VOLUNTEER DENTAL PROJECTS AND ACTION FOR  
5                   DENTAL HEALTH PROGRAM.**

6       Section ~~317M~~ of the Public Health Service Act (~~42~~  
7   U.S.C. ~~247b-14~~) is amended—

8               (1) by redesignating subsections (e) and (f) as  
9               subsections (f) and (g), respectively;

10              (2) by inserting after subsection (d) the fol-  
11               lowing new subsection:

12           **“(e) ACTION FOR DENTAL HEALTH PROGRAM.—**

13           **“(1) IN GENERAL.**—The Secretary, in consulta-  
14           tion with the Director of the Centers for Disease  
15           Control and Prevention and the Administrator of the  
16           Health Resources and Service Administration, may  
17           award grants to or enter into contracts with eligible  
18           entities to collaborate with State or local public offi-  
19           cials and other stakeholders to develop and imple-  
20           ment initiatives to—

21              “(A) improve oral health education and  
22               dental disease prevention, including—

23                  “(i) through community-wide preven-  
24               tion programs, such as programs that pro-  
25               mote the use of dental sealants and fluo-  
26               ride varnish; and

1               “(ii) by increasing public awareness  
2               and education related to oral health and  
3               dental disease prevention; or  
4               “(B) reduce barriers to the provision of  
5               dental services.

6               “(2) ELIGIBLE ENTITY.—In this subsection, the  
7               term ‘eligible entity’ means an entity that is—

8               “(A) a State or local dental association;  
9               “(B) a State oral health program;  
10               “(C) a dental education, dental hygiene, or  
11               postdoctoral dental education program accredited  
12               by the Commission on Dental Accreditation; or  
13               “(D) a community-based organization  
14               that—

16               “(i) partners with an academic institution;

18               “(ii) is exempt from tax under section  
19               501(e) of the Internal Revenue Code of  
20               1986; and

21               “(iii) partners with public and private  
22               stakeholders to facilitate the provision of  
23               dental services for underserved populations.”; and

1                             (3) in subsection (g), as redesignated by para-  
2                             graph (1), by striking “such sums as may be nec-  
3                             essary for each of the fiscal years 2001 through  
4                             2005” and inserting “\$18,000,000 for each of the  
5                             fiscal years 2018 through 2022”.

6 **SEC. 3. GRANTS FOR INNOVATIVE PROGRAMS.**

7                             Section 340G of the Public Health Service Act (42  
8 U.S.C. 256g) is amended—

9                             (1) in subsection (b)(5)—

10                             (A) in subparagraph (B), by striking  
11                             “and” at the end; and

12                             (B) by adding at the end the following:

13                             “(D) the establishment of dental homes for  
14                             children and adults, including for the aged,  
15                             blind, and disabled populations;

16                             “(E) the establishment of initiatives to re-  
17                             duce the use of emergency departments by indi-  
18                             viduals who seek dental services more appro-  
19                             priately delivered in a dental primary care set-  
20                             ting; and

21                             “(F) the provision of dental care to nurs-  
22                             ing home residents;”; and

23                             (2) in subsection (f), by striking “\$25,000,000  
24                             for the 5-fiscal year period beginning with fiscal year

1        2008” and inserting “\$13,903,000 for each of fiscal  
2        years 2018 through 2022”.

3        **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Action for Dental Health  
5        Act of 2018”.*

6        **SEC. 2. ORAL HEALTH EDUCATION.**

7        *(a) IN GENERAL.—Section 399LL of the Public Health  
8        Service Act (42 U.S.C. 280k) is amended—*

9              *(1) in subsection (a)—*

10              *(A) in the subsection heading, by inserting  
11              “OF ORAL HEALTH EDUCATION CAMPAIGN”  
12              after “ESTABLISHMENT”; and*

13              *(B) by striking “focused on oral healthcare  
14              prevention and education” and inserting “fo-  
15              cused on oral health education”;*

16              *(2) in subsection (b), in the matter preceding  
17              paragraph (1), by striking “campaign” and inserting  
18              “campaign under subsection (a)”; and*

19              *(3) by striking subsection (c) and inserting the  
20              following:*

21              *“(c) ACTION FOR DENTAL HEALTH PROGRAM.—*

22              *“(1) IN GENERAL.—The Secretary, in consulta-  
23              tion with the Director of the Centers for Disease Con-  
24              trol and Prevention and the Administrator of the  
25              Health Resources and Services Administration, may*

1       award grants, contracts, or cooperative agreements to  
2       eligible entities to collaborate with State or local pub-  
3       lic health officials, tribal health officials, oral health  
4       professional organizations, and others, as appro-  
5       priate, to develop and implement initiatives to im-  
6       prove oral health, including activities to prevent den-  
7       tal disease and reduce barriers to the provision of  
8       dental services, including—

9                 “(A) through community-wide dental dis-  
10          ease prevention programs; and  
11                 “(B) by increasing public awareness and  
12          education related to oral health and dental dis-  
13          ease prevention.

14       “(2) *ELIGIBLE ENTITIES*.—To be eligible to re-  
15       ceive a grant, contract, or cooperative agreement  
16       under this subsection, an entity shall be—

17                 “(A) a dental association;  
18                 “(B) a State or tribal health department or  
19          State or tribal oral health program;  
20                 “(C) an accredited dental education, dental  
21          hygiene, or postdoctoral dental education pro-  
22          gram; or  
23                 “(D) a non-profit community-based organi-  
24          zation that partners with public and private  
25          non-profit entities, such as an academic institu-

1           *tion, to facilitate the provision of dental services*  
2           *to underserved populations.”;*

3           *(b) TECHNICAL AMENDMENT.—Section 399LL-1(d) of*  
4   *the Public Health Service Act (42 U.S.C. 280k-1(d)) is*  
5   *amended—*

6           *(1) by striking “shall” and inserting “shall, as*  
7           *practicable and appropriate,” before “utilize”; and*  
8           *(2) by striking “public education campaign”*  
9           *and inserting “oral health education campaign and*  
10          *action for dental health program”.*

11          *(c) REPORT TO CONGRESS.—Not later than 3 years*  
12   *after the date of enactment of this Act, the Secretary of*  
13   *Health and Human Services shall submit to the Committee*  
14   *on Health, Education, Labor, and Pensions of the Senate*  
15   *and the Committee on Energy and Commerce of the House*  
16   *of Representatives, a report on the outcomes and effective-*  
17   *ness of programs and activities conducted under sections*  
18   *399LL and 399LL-1 of the Public Health Service Act (42*  
19   *U.S.C. 280k and 280k-1).*

20   **SEC. 3. GRANTS FOR INNOVATIVE PROGRAMS.**

21          *Section 340G of the Public Health Service Act (42*  
22   *U.S.C. 256g) is amended—*

23          *(1) in subsection (b)(5)—*

24           *(A) in subparagraph (B), by striking “and”*  
25           *at the end; and*

1                   (B) by adding at the end the following:

2                   “(D) the establishment or development of  
3                   models for the provision of dental services to  
4                   children and adults, such as dental homes, in-  
5                   cluding for the elderly, blind, individuals with  
6                   disabilities, and individuals living in long-term  
7                   care facilities; and

8                   “(E) the establishment of initiatives to re-  
9                   duce the use of emergency departments by indi-  
10                  viduals who seek dental services more appro-  
11                  priately delivered in a dental primary care set-  
12                  ting;”; and

13                  (2) in subsection (f), by striking “\$25,000,000  
14                  for the 5-fiscal year period beginning with fiscal year  
15                  2008” and inserting “\$13,903,000 for each of fiscal  
16                  years 2019 through 2023”.
