Mr. BLUNT introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To authorize the Secretary of the Interior to accept certain properties in the State of Missouri.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORITY OF SECRETARY OF INTERIOR TO**
4 **ACCEPT CERTAIN PROPERTIES, MISSOURI.**

5 (a) STE. GENEVIEVE NATIONAL HISTORICAL
6 PARK.—Section 7134(e)(1) of the Energy and Natural
7 Resources Act of 2017 (as enacted into law by section
8 121(a)(2) of division G of the Consolidated Appropriations
9 Act, 2018 (Public Law 115–141)) is amended, in the mat-
10 ter preceding subparagraph (A), by striking “any nation-

1 ally significant property identified in the special resource
 2 study within” and inserting “any property within”.

3 (b) HARRY S TRUMAN NATIONAL HISTORIC SITE.—

4 Public Law 98–32 (54 U.S.C. 320101 note) is amended—

5 (1) in section 3, by striking the section designa-
 6 tion and all that follows through “is authorized” and
 7 inserting the following:

8 **“SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

9 “There are authorized”;

10 (2) in section 2—

11 (A) in the second sentence, by striking
 12 “The Secretary is further authorized, in the ad-
 13 ministration of the site, to” and inserting the
 14 following:

15 “(b) USE BY MARGARET TRUMAN DANIEL.—In ad-
 16 ministering the Harry S Truman National Historic Site,
 17 the Secretary may”; and

18 (B) by striking the section designation and
 19 all that follows through “and shall be” in the
 20 first sentence and inserting the following:

21 **“SEC. 3. DESIGNATION; USE BY MARGARET TRUMAN DAN-**

22 **IEL.**

23 “(a) DESIGNATION.—Any property acquired pursu-
 24 ant to section 2—

1 “(1) is designated as the ‘Harry S Truman Na-
2 tional Historic Site’; and

3 “(2) shall be”; and

4 (3) in the first section—

5 (A) by redesignating subsection (e) as
6 paragraph (2), indenting the paragraph appro-
7 priately, and moving the paragraph so as to ap-
8 pear at the end of subsection (c);

9 (B) in subsection (c)—

10 (i) by striking the subsection designa-
11 tion and all that follows through “author-
12 ized to” and inserting the following:

13 “(c) TRUMAN FARM HOME.—

14 “(1) IN GENERAL.—The Secretary may”; and

15 (ii) in paragraph (2) (as redesignated
16 by subparagraph (A))—

17 (I) by striking “Farm House”
18 and inserting “Farm Home”; and

19 (II) by striking the paragraph
20 designation and all that follows
21 through “authorized and directed to”
22 and inserting the following:

23 “(2) TECHNICAL AND PLANNING ASSIST-
24 ANCE.—The Secretary shall”; and

25 (C) in subsection (b)—

1 (i) by striking “(b)(1) The Secretary
 2 is further authorized to” and inserting the
 3 following:

4 “(b) NOLAND/HAUKENBERRY AND WALLACE
 5 HOUSES.—

6 “(1) IN GENERAL.—The Secretary may”; and

7 (ii) in paragraph (1), by indenting
 8 subparagraphs (A) and (B) appropriately;
 9 (D) by adding at the end the following:

10 “(e) ADDITIONAL LAND IN INDEPENDENCE FOR VIS-
 11 ITOR CENTER.—

12 “(1) IN GENERAL.—The Secretary may acquire,
 13 by donation from the city of Independence, Missouri,
 14 the land described in paragraph (2) for—

15 “(A) inclusion in the Harry S Truman Na-
 16 tional Historic Site; and

17 “(B) if the Secretary determines appro-
 18 priate, use as a visitor center of the historic
 19 site, which may include administrative services.

20 “(2) DESCRIPTION OF LAND.—The land re-
 21 ferred to in paragraph (1) consists of the approxi-
 22 mately 1.08 acres of land—

23 “(A) owned by the city of Independence,
 24 Missouri;

1 “(B) designated as Lots 6 through 19,
 2 DELAYS Subdivision, a subdivision in Inde-
 3 pendence, Jackson County, Missouri; and

4 “(C) located in the area of the city bound
 5 by Truman Road on the south, North Lynn
 6 Street on the west, East White Oak Street on
 7 the north, and the city transit center on the
 8 east.

9 “(3) BOUNDARY MODIFICATION.—On acquisi-
 10 tion of the land under this subsection, the Secretary
 11 shall modify the boundary of the Harry S Truman
 12 National Historic Site to reflect that acquisition.”;
 13 and

14 (E) in subsection (a)—

15 (i) in the second sentence, by striking
 16 “The Secretary may also acquire, by any
 17 of the above means, fixtures,” and insert-
 18 ing the following:

19 “(2) FIXTURES AND PERSONAL PROPERTY.—
 20 The Secretary may acquire, by any means described
 21 in paragraph (1), any fixtures”; and

22 (ii) in the first sentence—

23 (I) by striking “of the Interior
 24 (hereinafter referred to as the ‘Sec-
 25 retary’)”; and

1 (II) by striking “That (a) in
2 order to” and inserting the following:

3 **“SECTION 1. SHORT TITLE; DEFINITION OF SECRETARY.**

4 “(a) SHORT TITLE.—This Act may be cited as the
5 ‘Harry S Truman National Historic Site Establishment
6 Act’.

7 “(b) DEFINITION OF SECRETARY.—In this Act, the
8 term ‘Secretary’ means the Secretary of the Interior.

9 **“SEC. 2. PURPOSE; ACQUISITION OF PROPERTY.**

10 “(a) PURPOSE; ACQUISITION.—

11 “(1) IN GENERAL.—To”.
