- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fix Immediately Out-
- 5 standing Underpayments for Student Veterans Act of
- 6 2018" or the "Fix IOUs for Student Veterans Act of
- 7 2018".

1	SEC. 2. PAYMENT OF AMOUNTS OWED UNDER POST-9/11
2	EDUCATIONAL ASSISTANCE PROGRAM.
3	(a) In General.—The Secretary of Veterans Affairs
4	shall ensure that on or before the date that is 60 days
5	after the date of the enactment of this Act, each individual
6	who received a monthly stipend under section 3313 of title
7	38, United States Code, during the period beginning on
8	August 1, 2018, and ending on December 31, 2018, in
9	an amount that was less than the amount to which the
10	individual was entitled under such section is provided an
11	amount that is equal to the difference between—
12	(1) the amount of monthly stipend to which the
13	individual is entitled under such section; and
14	(2) the amount of monthly stipend the indi-
15	vidual received under such section.
16	(b) Establishment of Commission.—The Sec-
17	retary shall establish a commission on the correction of
18	payments of monthly stipend under such section that were
19	deficient as a result of difficulties encountered by the De-
20	partment of Veterans Affairs in carrying out such section
21	after the enactment of sections 107 and 501 of the Harry
22	W. Colmery Veterans Educational Assistance Act of 2017
23	(Public Law 115–48; 38 U.S.C. 3313 note and 37 U.S.C.
24	403 note).
25	(c) Audits.—The commission established under sub-
26	section (b) shall audit each payment of monthly stipend

- 2 August 1, 2018, and ending on December 31, 2018, to
- 3 determine whether the amount of the payment was defi-
- 4 cient with respect to the amounts of monthly stipend that
- 5 were required pursuant to section 3313 of such title as
- 6 in effect at the time.
- 7 (d) Hiring Authority.—The Secretary may hire
- 8 such personnel as the Secretary considers appropriate to
- 9 carry out this section.
- 10 (e) Treatment of Overpayments.—An overpay-
- 11 ment of monthly stipend under section 3313 of title 38,
- 12 United States Code, that occurred during the period be-
- 13 ginning on August 1, 2018, and ending on December 31,
- 14 2018, and that occurred as a result of difficulties de-
- 15 scribed in subsection (b) shall be treated as if the Sec-
- 16 retary had made a determination under section 5302(a)
- 17 of such title that recovery would be against equity and
- 18 good conscience.
- 19 (f) AUTHORIZATION OF APPROPRIATIONS.—There is
- 20 authorized to be appropriated to the Secretary such sums
- 21 as may be necessary to carry out this section.
