CONCURRENT RESOLUTION

Directing the Secretary of the Senate to make a correction
in the enrollment of the bill S. 2330.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That in the enrollment of S. 2330, an Act
3 to amend the Ted Stevens Olympic and Amateur Sports
4 Act to provide for congressional oversight of the board of
5 directors of the United States Olympic and Paralympic
6 Committee and to protect amateur athletes from emo-
7 tional, physical, and sexual abuse, and for other purposes,
8 the Secretary of the Senate shall—

1 (1) in subsection (b)(2)(D) of section 220504 of
 2 title 36, United States Code, as amended by section
 3 6(b)(2) of the Act, strike “percent”;

4 (2) in subsection (a)(1)(H) of section 220541 of
 5 title 36 United States Code, as added by section
 6 8(a)(1)(B) of the Act, strike “in a manner than”
 7 and insert “in a manner that”;

8 (3) in subsection (f)(4)(B) of section 220541 of
 9 title 36 United States Code, as added by section
 10 8(a)(1)(E) of the Act, insert “and the Committee on
 11 the Judiciary” after “the Committee on Energy and
 12 Commerce”;

13 (4) amend paragraph (1) of section 220541(g)
 14 of title 36, United States Code, as added by section
 15 8(a)(1)(E) of the Act, to read as follows:

16 “(1) MANDATORY PAYMENTS.—

17 “(A) FISCAL YEAR 2021.—On January 4,
 18 2021, the corporation shall make a mandatory
 19 payment of \$20,000,000 to the Center for oper-
 20 ating costs of the Center for fiscal year 2021.

21 “(B) SUBSEQUENT FISCAL YEARS.—For
 22 fiscal year 2022 and each year thereafter, the
 23 corporation shall make a mandatory payment of
 24 \$20,000,000 to the Center not later than the

1 close of business on the first regular business
2 day in January.”; and

3 (5) in subsection (h)(2)(C)(iii) of section
4 220541 of title 36 United States Code, as added by
5 section 8(a)(1)(E) of the Act, insert “and the Com-
6 mittee on the Judiciary” after “the Committee on
7 Energy and Commerce”.
