A BILL

To regulate assault weapons, to ensure that the right to keep and bear arms is not unlimited, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Assault Weapons Ban
 5 of 2019”.

6 **SEC. 2. DEFINITIONS.**

7 (a) IN GENERAL.—Section 921(a) of title 18, United
 8 States Code, is amended—

9 (1) by inserting after paragraph (29) the fol-
 10 lowing:

11 “(30) The term ‘semiautomatic pistol’ means any re-
 12 peating pistol that—

1 “(A) utilizes a portion of the energy of a firing
2 cartridge to extract the fired cartridge case and
3 chamber the next round; and

4 “(B) requires a separate pull of the trigger to
5 fire each cartridge.

6 “(31) The term ‘semiautomatic shotgun’ means any
7 repeating shotgun that—

8 “(A) utilizes a portion of the energy of a firing
9 cartridge to extract the fired cartridge case and
10 chamber the next round; and

11 “(B) requires a separate pull of the trigger to
12 fire each cartridge.”; and

13 (2) by adding at the end the following:

14 “(36) The term ‘semiautomatic assault weapon’
15 means any of the following, regardless of country of manu-
16 facture or caliber of ammunition accepted:

17 “(A) A semiautomatic rifle that has the capac-
18 ity to accept a detachable magazine and any one of
19 the following:

20 “(i) A pistol grip.

21 “(ii) A forward grip.

22 “(iii) A folding, telescoping, or detachable
23 stock, or is otherwise foldable or adjustable in
24 a manner that operates to reduce the length,

1 size, or any other dimension, or otherwise en-
2 hances the concealability, of the weapon.

3 “(iv) A grenade launcher.

4 “(v) A barrel shroud.

5 “(vi) A threaded barrel.

6 “(B) A semiautomatic rifle that has a fixed
7 magazine with the capacity to accept more than 10
8 rounds, except for an attached tubular device de-
9 signed to accept, and capable of operating only with,
10 .22 caliber rimfire ammunition.

11 “(C) Any part, combination of parts, compo-
12 nent, device, attachment, or accessory that is de-
13 signed or functions to accelerate the rate of fire of
14 a semiautomatic rifle but not convert the semiauto-
15 matic rifle into a machinegun.

16 “(D) A semiautomatic pistol that has the ca-
17 pacity to accept a detachable magazine and any one
18 of the following:

19 “(i) A threaded barrel.

20 “(ii) A second pistol grip.

21 “(iii) A barrel shroud.

22 “(iv) The capacity to accept a detachable
23 magazine at some location outside of the pistol
24 grip.

1 “(v) A semiautomatic version of an auto-
2 matic firearm.

3 “(vi) A manufactured weight of 50 ounces
4 or more when unloaded.

5 “(vii) A stabilizing brace or similar compo-
6 nent.

7 “(E) A semiautomatic pistol with a fixed maga-
8 zine that has the capacity to accept more than 10
9 rounds.

10 “(F) A semiautomatic shotgun that has any one
11 of the following:

12 “(i) A folding, telescoping, or detachable
13 stock.

14 “(ii) A pistol grip.

15 “(iii) A fixed magazine with the capacity to
16 accept more than 5 rounds.

17 “(iv) The ability to accept a detachable
18 magazine.

19 “(v) A forward grip.

20 “(vi) A grenade launcher.

21 “(G) Any shotgun with a revolving cylinder.

22 “(H) All of the following rifles, copies, dupli-
23 cates, variants, or altered facsimiles with the capa-
24 bility of any such weapon thereof:

25 “(i) All AK types, including the following:

1 “(I) AK, AK-47, AK-47S, AK-74,

5 firearm described in subparagraphs (A) through (K)
6 can be assembled.

7 “(M) The frame or receiver of a rifle or shot-
8 gun described in subparagraph (A), (B), (C), (F),
9 (G), (H), (J), or (K).

10 “(37) The term ‘large capacity ammunition feeding
11 device’—

12 “(A) means a magazine, belt, drum, feed strip,
13 or similar device, including any such device joined or
14 coupled with another in any manner, that has an
15 overall capacity of, or that can be readily restored,
16 changed, or converted to accept, more than 10
17 rounds of ammunition; and

18 “(B) does not include an attached tubular de-
19 vice designed to accept, and capable of operating
20 only with, .22 caliber rimfire ammunition.”.

21 (b) RELATED DEFINITIONS.—Section 921(a) of title
22 18, United States Code, as amended by this Act, is
23 amended by adding at the end the following:

24 “(38) The term ‘barrel shroud’—

1 “(A) means a shroud that is attached to, or
2 partially or completely encircles, the barrel of a fire-
3 arm so that the shroud protects the user of the fire-
4 arm from heat generated by the barrel; and

5 “(B) does not include—

6 “(i) a slide that partially or completely en-
7 closes the barrel; or

8 “(ii) an extension of the stock along the
9 bottom of the barrel which does not encircle or
10 substantially encircle the barrel.

11 “(39) The term ‘detachable magazine’ means an am-
12 munition feeding device that can be removed from a fire-
13 arm without disassembly of the firearm action.

14 “(40) The term ‘fixed magazine’ means an ammuni-
15 tion feeding device that is permanently fixed to the firearm
16 in such a manner that it cannot be removed without dis-
17 assembly of the firearm.

18 “(41) The term ‘folding, telescoping, or detachable
19 stock’ means a stock that folds, telescopes, detaches or
20 otherwise operates to reduce the length, size, or any other
21 dimension, or otherwise enhances the concealability, of a
22 firearm.

23 “(42) The term ‘forward grip’ means a grip located
24 forward of the trigger that functions as a pistol grip.

1 “(43) The term ‘grenade launcher’ means an attach-
2 ment for use on a firearm that is designed to propel a
3 grenade or other similar destructive device.

4 “(44) The term ‘permanently inoperable’ means a
5 firearm which is incapable of discharging a shot by means
6 of an explosive and incapable of being readily restored to
7 a firing condition.

8 “(45) The term ‘pistol grip’ means a grip, a thumb-
9 hole stock or Thordsen-type grip or stock, or any other
10 characteristic that can function as a grip.

11 “(46) The term ‘threaded barrel’ means a feature or
12 characteristic that is designed in such a manner to allow
13 for the attachment of a device such as a firearm silencer
14 or a flash suppressor.

15 “(47) The term ‘qualified law enforcement officer’
16 has the meaning given the term in section 926B.

17 “(48) The term ‘grandfathered semiautomatic as-
18 sault weapon’ means any semiautomatic assault weapon
19 the importation, possession, sale, or transfer of which
20 would be unlawful under section 922(v) but for the excep-
21 tion under paragraph (2) of such section.

22 “(49) The term ‘belt-fed semiautomatic firearm’
23 means any repeating firearm that—

1 “(A) utilizes a portion of the energy of a firing
2 cartridge to extract the fired cartridge case and
3 chamber the next round;

4 “(B) requires a separate pull of the trigger to
5 fire each cartridge; and

6 “(C) has the capacity to accept a belt ammuni-
7 tion feeding device.”.

8 **SEC. 3. RESTRICTIONS ON ASSAULT WEAPONS AND LARGE**
9 **CAPACITY AMMUNITION FEEDING DEVICES.**

10 (a) IN GENERAL.—Section 922 of title 18, United
11 States Code, is amended—

12 (1) by inserting after subsection (u) the fol-
13 lowing:

14 “(v)(1) It shall be unlawful for a person to import,
15 sell, manufacture, transfer, or possess, in or affecting
16 interstate or foreign commerce, a semiautomatic assault
17 weapon.

18 “(2) Paragraph (1) shall not apply to the possession,
19 sale, or transfer of any semiautomatic assault weapon oth-
20 erwise lawfully possessed under Federal law on the date
21 of enactment of the Assault Weapons Ban of 2019.

22 “(3) Paragraph (1) shall not apply to any firearm
23 that—

24 “(A) is manually operated by bolt, pump, lever,
25 or slide action;

1 “(B) has been rendered permanently inoperable;
2 or

3 “(C) is an antique firearm, as defined in section
4 921 of this title.

5 “(4) Paragraph (1) shall not apply to—

6 “(A) the importation for, manufacture for, sale
7 to, transfer to, or possession by the United States
8 or a department or agency of the United States or
9 a State or a department, agency, or political subdivi-
10 sion of a State, or a sale or transfer to or possession
11 by a qualified law enforcement officer employed by
12 the United States or a department or agency of the
13 United States or a State or a department, agency,
14 or political subdivision of a State, for purposes of
15 law enforcement (whether on or off duty), or a sale
16 or transfer to or possession by a campus law en-
17 forcement officer for purposes of law enforcement
18 (whether on or off duty);

19 “(B) the importation for, or sale or transfer to
20 a licensee under title I of the Atomic Energy Act of
21 1954 for purposes of establishing and maintaining
22 an on-site physical protection system and security
23 organization required by Federal law, or possession
24 by an employee or contractor of such licensee on-site
25 for such purposes or off-site for purposes of licensee-

1 authorized training or transportation of nuclear ma-
2 terials;

3 “(C) the possession, by an individual who is re-
4 tired in good standing from service with a law en-
5 forcement agency and is not otherwise prohibited
6 from receiving a firearm, of a semiautomatic assault
7 weapon—

8 “(i) sold or transferred to the individual by
9 the agency upon such retirement; or

10 “(ii) that the individual purchased, or oth-
11 erwise obtained, for official use before such re-
12 tirement;

13 “(D) the importation, sale, manufacture, trans-
14 fer, or possession of a semiautomatic assault weapon
15 by a licensed manufacturer or licensed importer for
16 the purposes of testing or experimentation author-
17 ized by the Attorney General; or

18 “(E) the importation, sale, manufacture, trans-
19 fer, or possession of a firearm specified in Appendix
20 A to this section, as such firearm was manufactured
21 on the date of introduction of the Assault Weapons
22 Ban of 2019.

23 “(5) For purposes of paragraph (4)(A), the term
24 ‘campus law enforcement officer’ means an individual who
25 is—

1 “(A) employed by a private institution of higher
2 education that is eligible for funding under title IV
3 of the Higher Education Act of 1965 (20 U.S.C.
4 1070 et seq.);

5 “(B) responsible for the prevention or investiga-
6 tion of crime involving injury to persons or property,
7 including apprehension or detention of persons for
8 such crimes;

9 “(C) authorized by Federal, State, or local law
10 to carry a firearm, execute search warrants, and
11 make arrests; and

12 “(D) recognized, commissioned, or certified by
13 a government entity as a law enforcement officer.

14 “(6) The Attorney General shall establish and main-
15 tain, in a timely manner, a record of the make, model,
16 and, if available, date of manufacture of any semiauto-
17 matic assault weapon which the Attorney General is made
18 aware has been used in relation to a crime under Federal
19 or State law, and the nature and circumstances of the
20 crime involved, including the outcome of relevant criminal
21 investigations and proceedings. The Attorney General
22 shall annually submit a copy of the record established
23 under this paragraph to the Congress and make the record
24 available to the general public.

1 “(w)(1) It shall be unlawful for a person to import,
2 sell, manufacture, transfer, or possess, in or affecting
3 interstate or foreign commerce, a large capacity ammuni-
4 tion feeding device.

5 “(2) Paragraph (1) shall not apply to the possession
6 of any large capacity ammunition feeding device otherwise
7 lawfully possessed on or before the date of enactment of
8 the Assault Weapons Ban of 2019.

9 “(3) Paragraph (1) shall not apply to—

10 “(A) the importation for, manufacture for, sale
11 to, transfer to, or possession by the United States
12 or a department or agency of the United States or

25 1954 for purposes of establishing and maintaining

1 an on-site physical protection system and security
2 organization required by Federal law, or possession
3 by an employee or contractor of such licensee on-site
4 for such purposes or off-site for purposes of licensee-
5 authorized training or transportation of nuclear ma-
6 terials;

7 “(C) the possession, by an individual who is re-
8 tired in good standing from service with a law en-
9 forcement agency and is not otherwise prohibited
10 from receiving ammunition, of a large capacity am-
11 munition feeding device—

12 “(i) sold or transferred to the individual by
13 the agency upon such retirement; or

14 “(ii) that the individual purchased, or oth-
15 erwise obtained, for official use before such re-
16 tirement; or

17 “(D) the importation, sale, manufacture, trans-
18 fer, or possession of any large capacity ammunition
19 feeding device by a licensed manufacturer or licensed
20 importer for the purposes of testing or experimen-
21 tation authorized by the Attorney General.

22 “(4) For purposes of paragraph (3)(A), the term
23 ‘campus law enforcement officer’ means an individual who
24 is—

1 “(A) employed by a private institution of higher
2 education that is eligible for funding under title IV
3 of the Higher Education Act of 1965 (20 U.S.C.
4 1070 et seq.);

5 “(B) responsible for the prevention or investiga-
6 tion of crime involving injury to persons or property,
7 including apprehension or detention of persons for
8 such crimes;

9 “(C) authorized by Federal, State, or local law
10 to carry a firearm, execute search warrants, and
11 make arrests; and

12 “(D) recognized, commissioned, or certified by
13 a government entity as a law enforcement officer.”;
14 and

15 (2) by adding at the end the following:

16 “(aa) SECURE STORAGE OR SAFETY DEVICE RE-
17 QUIREMENT FOR GRANDFATHERED SEMIAUTOMATIC AS-
18 SAULT WEAPONS.—It shall be unlawful for any person,
19 other than a licensed importer, licensed manufacturer, or
20 licensed dealer, to store or keep under the dominion or
21 control of that person any grandfathered semiautomatic
22 assault weapon that the person knows, or has reasonable
23 cause to believe, will be accessible to an individual prohib-
24 ited from receiving or possessing a firearm under sub-

1 section (g), (n), or (x), or any provision of State law, un-
2 less the grandfathered semiautomatic assault weapon is—

3 “(1) carried on the person, or within such close
4 proximity that the person can readily retrieve and
5 use the grandfathered semiautomatic assault weapon
6 as if the grandfathered semiautomatic assault weap-
7 on were carried on the person; or

8 “(2) locked by a secure gun storage or safety
9 device that the prohibited individual has no ability to
10 access.”.

11 (b) IDENTIFICATION MARKINGS FOR SEMIAUTO-
12 Matic Assault Weapons.—Section 923(i) of title 18,
13 United States Code, is amended by adding at the end the
14 following: “The serial number of any semiautomatic as-
15 sault weapon manufactured after the date of enactment
16 of the Assault Weapons Ban of 2019 shall clearly show
17 the date on which the weapon was manufactured or made,
18 legibly and conspicuously engraved or cast on the weapon,
19 and such other identification as the Attorney General shall
20 by regulations prescribe.”.

21 (c) IDENTIFICATION MARKINGS FOR LARGE CAPAC-
22 ity Ammunition Feeding Devices.—Section 923(i) of
23 title 18, United States Code, as amended by this Act, is
24 amended by adding at the end the following: “A large ca-
25 pacity ammunition feeding device manufactured after the

1 date of enactment of the Assault Weapons Ban of 2019
2 shall be identified by a serial number and the date on
3 which the device was manufactured or made, legibly and
4 conspicuously engraved or cast on the device, and such
5 other identification as the Attorney General shall by regu-
6 lations prescribe.”.

7 **SEC. 5. BACKGROUND CHECKS FOR TRANSFERS OF GRAND-**
8 **FATHERED SEMIAUTOMATIC ASSAULT WEAP-**
9 **ONS.**

10 (a) IN GENERAL.—Section 922 of title 18, United
11 States Code, as amended by this Act, is amended—

12 (1) by repealing subsection (s);

13 (2) by redesignating subsection (t) as sub-
14 section (s);

15 (3) in subsection (s), as redesignated—

16 (A) in paragraph (3)(C)(ii), by striking
17 “(as defined in subsection (s)(8))”; and

18 (B) by adding at the end the following:

19 “(7) In this subsection, the term ‘chief law en-
20 forcement officer’ means the chief of police, the
21 sheriff, or an equivalent officer or the designee of
22 any such individual.”; and

23 (4) by inserting after subsection (s), as redesign-
24 nated, the following:

1 “(t)(1) Beginning on the date that is 90 days after
2 the date of enactment of the Assault Weapons Ban of
3 2019, it shall be unlawful for any person who is not li-
4 censed under this chapter to transfer a grandfathered
5 semiautomatic assault weapon to any other person who is
6 not licensed under this chapter, unless a licensed importer,
7 licensed manufacturer, or licensed dealer has first taken
8 custody of the grandfathered semiautomatic assault weap-
9 on for the purpose of complying with subsection (s). Upon
10 taking custody of the grandfathered semiautomatic assault
11 weapon, the licensee shall comply with all requirements of
12 this chapter as if the licensee were transferring the grand-
13 fathered semiautomatic assault weapon from the licensee’s
14 inventory to the unlicensed transferee.

15 “(2) Paragraph (1) shall not apply to a temporary
16 transfer of possession for the purpose of participating in
17 target shooting in a licensed target facility or established
18 range if—

19 “(A) the grandfathered semiautomatic assault
20 weapon is, at all times, kept within the premises of
21 the target facility or range; and

22 “(B) the transferee is not known to be prohib-
23 ited from possessing or receiving a grandfathered
24 semiautomatic assault weapon.

1 “(3) For purposes of this subsection, the term ‘trans-
2 fer’—

3 “(A) shall include a sale, gift, or loan; and

4 “(B) does not include temporary custody of the
5 grandfathered semiautomatic assault weapon for
6 purposes of examination or evaluation by a prospec-
7 tive transferee.

8 “(4)(A) Notwithstanding any other provision of this
9 chapter, the Attorney General may implement this sub-
10 section with regulations.

11 “(B) Regulations promulgated under this para-
12 graph—

13 “(i) shall include a provision setting a max-
14 imum fee that may be charged by licensees for serv-
15 ices provided in accordance with paragraph (1); and

16 “(ii) shall not include any provision imposing
17 recordkeeping requirements on any unlicensed trans-
18 feror or requiring licensees to facilitate transfers in
19 accordance with paragraph (1).”.

1 (2) SECTION 925A.—Section 925A of title 18,
 2 United States Code, is amended, in the matter pre-
 3 ceding paragraph (1), by striking “subsection (s) or
 4 (t) of section 922” and inserting “section 922(s)”.

5 (c) EFFECTIVE DATE.—The amendments made by
 6 this section shall take effect 90 days after the date of en-
 7 actment of this Act.

8 **SEC. 6. NOTIFICATION TO LAW ENFORCEMENT AGENCIES**
 9 **OF PROHIBITED PURCHASE OR ATTEMPTED**
 10 **PURCHASE OF A FIREARM.**

11 (a) IN GENERAL.—Title I of the NICS Improvement
 12 Amendments Act of 2007 (34 U.S.C. 40911–40916) is
 13 amended by adding at the end the following:

14 **“SEC. 107. NOTIFICATION TO LAW ENFORCEMENT AGEN-**
 15 **CIES OF PROHIBITED PURCHASE OR AT-**
 16 **TEMPTED PURCHASE OF A GRANDFATHERED**
 17 **SEMIAUTOMATIC ASSAULT WEAPON.**

18 “(a) IN GENERAL.—In the case of a background
 19 check conducted by the National Instant Criminal Back-
 20 ground Check System pursuant to the request of a li-
 21 censed importer, licensed manufacturer, or licensed dealer
 22 of firearms (as such terms are defined in section 921 of
 23 title 18, United States Code), which background check de-
 24 termines that the receipt of a grandfathered semiauto-
 25 matic assault weapon (as defined in section 921(a)(49) of

1 title 18, United States Code) by a person would violate
 2 subsection (g) or (n) of section 922 of title 18, United
 3 States Code, the System shall notify the law enforcement
 4 agencies described in subsection (b), including in a case
 5 where such a determination is made after 14 business days
 6 have elapsed since the licensee contacted the System.

7 “(b) LAW ENFORCEMENT AGENCIES DESCRIBED.—
 8 The law enforcement agencies described in this subsection
 9 are the law enforcement agencies that have jurisdiction
 10 over the location from which the licensee contacted the
 11 System and the law enforcement agencies that have juris-
 12 diction over the location of the residence of the person for
 13 which the background check was conducted, as follows:

14 “(1) The field office of the Federal Bureau of
 15 Investigation.

16 “(2) The local law enforcement agency.

17 “(3) The State law enforcement agency.”.

18 (b) CLERICAL AMENDMENT.—Section 1(b) of such
 19 Act (34 U.S.C. ch. 409, front matter) is amended by in-
 20 serting after the item relating to section 106 the following:

“107. Notification to law enforcement agencies of prohibited purchase or at-
 tempted purchase of a grandfathered semiautomatic assault
 weapon.”.

1 **SEC. 7. USE OF BYRNE GRANTS FOR BUY-BACK PROGRAMS**
2 **FOR SEMIAUTOMATIC ASSAULT WEAPONS**
3 **AND LARGE CAPACITY AMMUNITION FEED-**
4 **ING DEVICES.**

5 Section 501(a)(1) of the Omnibus Crime Control and
6 Safe Streets Act of 1968 (42 U.S.C. 3751(a)(1)) is
7 amended by adding at the end the following:

8 “(H) Compensation for surrendered semi-
9 automatic assault weapons and large capacity
10 ammunition feeding devices, as those terms are
11 defined in section 921 of title 18, United States
12 Code, under buy-back programs for semiauto-
13 matic assault weapons and large capacity am-
14 munition feeding devices.”.

15 **SEC. 8. SEVERABILITY.**

16 If any provision of this Act, an amendment made by
17 this Act, or the application of such provision or amend-
18 ment to any person or circumstance is held to be unconsti-
19 tutional, the remainder of this Act, the amendments made
20 by this Act, and the application of such provision or
21 amendment to any person or circumstance shall not be af-
22 fected thereby.
