1 gency Assistance Act (42 U.S.C. 5174), as in effect 2 before the date of enactment of this Act, for the re-3 moval of debris from an owner-occupied private resi-4 dence or property and the request for such assist-5 ance was denied before the date of enactment of this 6 Act, the request for assistance under such section 7 408, as amended by this Act, may be resubmitted. 8 SEC. 3. FACTORS TO BE CONSIDERED IN MAJOR DISASTER 9 **DECLARATIONS.** 

10 Not later than 180 days after the date of enactment 11 of this Act, the Administrator of the Federal Emergency 12 Management Agency shall, by rulemaking, amend the fac-13 tors considered when evaluating a Governor's request for 14 a major disaster declaration under the Robert T. Stafford 15 Disaster Relief and Emergency Assistance Act (42 U.S.C. 16 5121 et seq.) to include the estimated cost of removing fallen debris from owner-occupied private residences and 17 18 property.
