AN ACT

Making emergency supplemental appropriations for the fiscal year ending September 30, 2020, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Emergency Supple-
- 5 mental Appropriations for Disaster Relief and Puerto Rico
- 6 Disaster Tax Relief Act, 2020".
