## A BILL

To designate certain future interstates and high priority  
corridors in Kentucky, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. LOUIE B. NUNN (CUMBERLAND) PARKWAY.**

4       (a) DESIGNATION AS HIGH PRIORITY CORRIDOR.—  
5       Section 1105(c) of the Intermodal Surface Transportation  
6       Efficiency Act of 1991 is amended by adding at the end  
7       the following:

8               “(92) The Louie B. Nunn (Cumberland) Park-  
9       way from the interchange with Interstate 65 in Bar-

1       ren County, Kentucky, east to the interchange with  
2       U.S. Highway 27 in Somerset, Kentucky.”.

3       (b) DESIGNATION AS FUTURE INTERSTATE.—Sec-  
4       tion 1105(e)(5)(A) of the Intermodal Surface Transpor-  
5       tation Efficiency Act of 1991 is amended by striking “and  
6       subsection (c)(91)” and inserting “subsection (c)(91), and  
7       subsection (c)(92)”.

8       (c) NUMBERING OF PARKWAY.—Section  
9       1105(e)(5)(C)(i) of the Intermodal Surface Transpor-  
10      tation Efficiency Act of 1991 is amended by adding at  
11      the end the following: “The route referred to in subsection  
12      (c)(92) is designated as Interstate Route I–365.”.

13      (d) OPERATION OF VEHICLES.—Section 127(l)(3)(A)  
14      of title 23, United States Code, is amended—

15           (1) in the matter preceding clause (i) by strik-  
16           ing “clauses (i) through (iv)” and inserting “clauses  
17           (i) through (v)”;

18           (2) by adding at the end the following:

19                   “(v) The Louie B. Nunn (Cum-  
20                   berland) Parkway (to be designated as a  
21                   spur of Interstate Route 65) from the  
22                   interchange with Interstate 65 in Barren  
23                   County, Kentucky, east to the interchange

1 with U.S. Highway 27 in Somerset, Ken-  
2 tucky.”.
