## A BILL

To allow certain governmental pension plans to include firefighters, emergency medical technicians, and paramedics, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. GOVERNMENTAL PENSION PLANS MAY IN-**  
2 **CLUDE CERTAIN FIREFIGHTERS, EMER-**  
3 **GENCY MEDICAL TECHNICIANS, AND PARA-**  
4 **MEDICS.**

5 (a) IN GENERAL.—Subsection (d) of section 414 of  
6 the Internal Revenue Code of 1986 (relating to govern-  
7 mental plans) is amended to read as follows:

8 “(d) GOVERNMENTAL PLAN.—

9 “(1) IN GENERAL.—For purposes of this part,  
10 the term ‘governmental plan’ means—

11 “(A) a plan established and maintained for  
12 its employees by the Government of the United  
13 States, by the government of any State or polit-  
14 ical subdivision thereof, or by any agency or in-  
15 strumentality of any of the foregoing,

16 “(B) any plan to which the Railroad Re-  
17 tirement Act of 1935 or 1937 applies and which  
18 is financed by contributions required under that  
19 Act,

20 “(C) any plan of an international organiza-  
21 tion which is exempt from taxation by reason of  
22 the International Organizations Immunities Act  
23 (59 Stat. 669), or

24 “(D) a plan which is established and main-  
25 tained by an Indian tribal government (as de-  
26 fined in section 7701(a)(40)), a subdivision of

1 an Indian tribal government (determined in ac-  
2 cordance with section 7871(d)), or an agency or  
3 instrumentality of either, and all of the partici-  
4 pants of which are employees of such entity  
5 substantially all of whose services as such an  
6 employee are in the performance of essential  
7 governmental functions but not in the perform-  
8 ance of commercial activities (whether or not an  
9 essential government function).

10 “(2) SPECIAL RULE FOR EMERGENCY RE-  
11 SPONSE PROVIDERS.—For purposes of paragraph  
12 (1), a public safety agency (described in section  
13 501(c) and exempt from taxation under section  
14 501(a)) that employs emergency response providers  
15 (defined in section 2 of the Homeland Security Act  
16 of 2002 (6 U.S.C. 101)), substantially all of whose  
17 services as emergency response providers are in the  
18 performance of firefighting services or out-of-hos-  
19 pital emergency medical services for a political sub-  
20 division of a State under a contract between such  
21 public safety agency and the political subdivision of  
22 a State, may opt to join the governmental plan of  
23 such State or political subdivision.”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 this section shall apply to plan years beginning after the  
3 date of the enactment of this Act.
