A BILL

To designate the Kissimmee Gateway Airport and certain
surrounding areas as an enterprise community.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF THE KISSIMMEE GATEWAY**

4 **AIRPORT AREA AS AN ENTERPRISE COMMU-**

5 **NITY.**

6 (a) IN GENERAL.—For purposes of subchapter U of
7 chapter 1 of the Internal Revenue Code of 1986, the Kis-
8 simmee Gateway Airport area shall be treated as an enter-
9 prise community designated as such under section 1391
10 of such Code on the date of the enactment of this Act.

1 (b) COORDINATION WITH LIMITATIONS ON OTHER
2 ENTERPRISE COMMUNITIES.—The enterprise community
3 referred to in subsection (a) shall not be taken into ac-
4 count for purposes of applying any limitation on the enter-
5 prise communities which may otherwise be designated
6 under section 1391 of such Code.

7 (c) KISSIMMEE GATEWAY AIRPORT AREA.—For pur-
8 poses of this section, the “Kissimmee Gateway Airport
9 area” means the area surrounding the Kissimmee Gate-
10 way Airport in Kissimmee, Florida, bound as follows (and
11 determined as of the date of the enactment of this Act):
12 beginning at the intersection of U.S. Highway 192 and
13 North Thacker Avenue, south along North Thacker Ave-
14 nue to South Thacker Avenue, then south along South
15 Thacker Avenue to the intersection of South Thacker Ave-
16 nue and Clay Street, then southwest along Clay Street to
17 Pug Mill Road, then southwest along Pug Mill Road to
18 the intersection of Pug Mill Road and South Hoagland
19 Boulevard, then southeast along South Hoagland Boule-
20 vard to the intersection of South Hoagland Boulevard and
21 Old Tampa Highway, then southwest along Old Tampa
22 Highway to the intersection of Old Tampa Highway and
23 Shingle Creek, then northerly along Shingle Creek to the
24 intersection of Shingle Creek and U.S. Highway 192, then

- 1 east along U.S. Highway 192 to the intersection of U.S.
- 2 Highway 192 and North Thacker Avenue.
