Mr. PETERSON introduced the following bill; which was referred to the
Committee on Agriculture

A BILL

To amend the Food Security Act of 1985 to increase the number of acres authorized for enrollment in the conservation reserve program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCREASE IN AUTHORIZED MAXIMUM ENROLL-**
4 **MENT IN CONSERVATION RESERVE.**

5 (a) GENERAL ENROLLMENT INCREASE.—Section
6 1231(d)(1) of the Food Security Act of 1985 (16 U.S.C.
7 3831(d)(1)(E)) is amended by striking subparagraphs (C)
8 through (E) and inserting the following:

1 “(C) fiscal year 2021, to the maximum ex-
2 tent practicable, not fewer than 28,000,000
3 acres;

4 “(D) fiscal year 2022, to the maximum ex-
5 tent practicable, not fewer than 32,000,000
6 acres;

7 “(E) fiscal year 2023, to the maximum ex-
8 tent practicable, not fewer than 37,000,000
9 acres;

10 “(F) fiscal year 2024, to the maximum ex-
11 tent practicable, not fewer than 43,000,000
12 acres; and

13 “(G) fiscal year 2025, to the maximum ex-
14 tent practicable, not fewer than 50,000,000
15 acres.”.

16 (b) LIMITATION.—The amendment made by sub-
17 section (a) shall have no effect on the number of acres
18 enrolled and maintained in the conservation reserve pro-
19 gram using the continuous enrollment procedure under
20 section 1231(d)(6) of the Food Security Act of 1985 (16
21 U.S.C. 3831(d)(6)).

22 (c) PRIORITY.—In holding a signup for general en-
23 rollment contracts for 25,000,000 acres of the total acres
24 authorized to be enrolled in the conservation reserve pro-
25 gram under subparagraphs (C) through (G) of section

1 1231(d)(1) of the Food Security Act of 1985 (16 U.S.C.
2 3831(d)(1)), the Secretary shall give priority to applica-
3 tions for the enrollment of land that would promote soil
4 health and carbon sequestration, including applications for
5 the enrollment of land on which deep-rooted perennials
6 will be planted.
