Mr. YOUNG introduced the following bill; which was referred to the Committee
on Natural Resources

A BILL

To require the Secretary of the Interior to convey certain
interests in land in the State of Alaska, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CANYON VILLAGE.**

4 (a) CONVEYANCE.—Notwithstanding section
5 2653.3(c) of title 43, Code of Federal Regulations (or suc-
6 cessor regulations), or the withdrawal made by section
7 303(2)(A) of the Alaska National Interest Lands Con-
8 servation Act (Public Law 96–487; 94 Stat. 2390), the
9 Secretary of the Interior (referred to in this section as
10 the “Secretary”) shall convey to Kian Tr’ee Corporation,

1 for the Native Village of Canyon Village, the surface estate
2 in the land selected by the Kian Tr'ee Corporation pursu-
3 ant to section 14(h)(2) of the Alaska Native Claims Settle-
4 ment Act (43 U.S.C. 1613(h)(2)).

5 (b) LIMITATION.—The conveyance under subsection
6 (a) shall not exceed 6,400 acres.

7 (c) SUBSURFACE ESTATE.—

8 (1) IN GENERAL.—Unless Doyon, Limited,
9 elects to receive conveyance under paragraph (2),
10 the Secretary shall convey to Doyon, Limited, the
11 subsurface estate in the land conveyed under sub-
12 section (a).

13 (2) ALTERNATE SELECTION.—At the option of
14 Doyon, Limited, in lieu of accepting the conveyance
15 under paragraph (1)—

16 (A) Doyon, Limited, may receive a convey-
17 ance from existing selections on land withdrawn
18 pursuant to section 11(a)(3) of the Alaska Na-
19 tive Claims Settlement Act (43 U.S.C.
20 1610(a)(3)) that is equal in acreage to the sub-
21 surface that would otherwise be conveyed under
22 paragraph (1);

23 (B) Doyon, Limited, shall notify the Sec-
24 retary (acting through the Alaska State Office
25 of the Bureau of Land Management) of the

1 preference of Doyon, Limited, not later than 90
2 days after the date of enactment of this Act;
3 and

4 (C) the Secretary shall convey to Doyon,
5 Limited, the subsurface estate selected under
6 subparagraph (A).
