#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Veteran Housing Op3 portunities and Unemployment Support Extension Act of
4 2019".

### 5 SEC. 2. EXPANSION OF ELIGIBILITY FOR HUD-VASH.

6 (a) HUD PROVISIONS.—Section 8(o)(19) of the
7 United States Housing Act of 1937 (42 U.S.C.
8 1437f(o)(19)) is amended by adding at the end the fol9 lowing new subparagraph:

10 "(D) VETERAN DEFINED.—In this para11 graph, the term 'veteran' has the meaning given
12 that term in section 2002(b) of title 38, United

(b) VHA CASE MANAGERS.—Subsection (b) of section 2003 of title 38, United States Code, is amended—
(1) by inserting "(1)" before "The Secretary";

"(2) In the case of vouchers provided under the
HUD–VASH program under section 8(o)(19) of such Act,
for purposes of paragraph (1), the term 'veteran' shall
have the meaning given such term in section 2002(b) of

1 (1) IN GENERAL.—Not less frequently than 2 once each year, the Secretary of Veterans Affairs 3 shall submit to the Committee on Veterans' Affairs 4 of the Senate and the Committee on Veterans' Af-5 fairs of the House of Representatives a report on the 6 homelessness services provided under programs of 7 the Department of Veterans Affairs, including serv-8 ices under HUD-VASH program under section 9 8(0)(1) of the United States Housing Act of 1937 10 (42 U.S.C. 1437f(o)(19)).

11 (2) INCLUDED INFORMATION.—Each such an-12 nual report shall include, with respect to the year 13 preceding the submittal of the report, a statement of 14 the number of eligible individuals who were fur-15 nished such homelessness services and the number of 16 individuals furnished such services under each such 17 program, disaggregated by the number of men who 18 received such services and the number of women 19 who received such services, and such other informa-20 tion as the Secretary considers appropriate.
