ferred to the Committee on Small Business and Entrepreneurship

A BILL

To reauthorize the Interagency Committee on Women’s
Business Enterprise, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Interagency Committee
5 on Women’s Business Enterprise Act of 2020”.

6 **SEC. 2. INTERAGENCY COMMITTEE ON WOMEN’S BUSINESS**
7 **ENTERPRISE.**

8 Title IV of the Women’s Business Ownership Act of
9 1988 (15 U.S.C. 7101 et seq.) is amended—

10 (1) in section 402 (15 U.S.C. 7102)—

1 (A) in subsection (a)—

2 (i) by striking paragraphs (2) and (5);

3 (ii) by redesignating paragraphs (3)

4 and (4) as paragraphs (2) and (3), respec-

5 tively; and

6 (iii) by adding at the end the fol-

7 lowing:

8 “(4) monitor the plans, programs, and oper-
9 ations of the departments and agencies of the Fed-
10 eral Government to identify barriers to new business
11 formation by women entrepreneurs, or barriers expe-
12 rienced by women-led startups in accessing and par-
13 ticipating in the plans, programs, and operations of
14 the departments and agencies of the Federal Gov-
15 ernment.”;

16 (B) in subsection (b), by inserting after
17 the second sentence the following: “In addition
18 to the meetings described in the preceding sen-
19 tence, the Interagency Committee shall meet at
20 the call of the executive director of the Council
21 or the chairperson of the Interagency Com-
22 mittee.”; and

23 (C) in subsection (c), in the first sentence,
24 by inserting “, including through the use of re-

1 search and policy developed by the Council”
2 after “Council”;

3 (2) in section 403 (15 U.S.C. 7103)—

4 (A) in subsection (a)—

5 (i) in paragraph (1)—

6 (I) in the matter preceding sub-
7 paragraph (A), by inserting “the exec-
8 utive director of the Council and” be-
9 fore “1 representative”; and

10 (II) by adding at the end the fol-
11 lowing:

12 “(K) The National Aeronautics and Space
13 Administration.

14 “(L) The Environmental Protection Agen-
15 cy.

16 “(M) The Deputy Director of Management
17 of the Office of Management and Budget.

18 “(N) The Bureau of Labor Statistics.

19 “(O) The Department of Homeland Secu-
20 rity.

21 “(P) The Department of Veterans Af-
22 fairs.”; and

23 (ii) in paragraph (2)—

24 (I) in subparagraph (A), by strik-
25 ing “Small Business Administration

1 Reauthorization Act of 1997” and in-
 2 serting “Interagency Committee on
 3 Women’s Business Enterprise Act of
 4 2020”; and

5 (II) in subparagraph (B)—

6 (aa) by striking “Small
 7 Business”; and

8 (bb) by striking “National
 9 Women’s Business Council estab-
 10 lished under section 405” and in-
 11 serting “Council”; and

12 (B) by amending subsection (b) to read as
 13 follows:

14 “(b) APPOINTMENT.—

15 “(1) IN GENERAL.—Not later than 45 days
 16 after the date of enactment of the Interagency Com-
 17 mittee on Women’s Business Enterprise Act of
 18 2020, the President, in consultation with the Admin-
 19 istrator, shall appoint one of the members of the
 20 Interagency Committee to serve as chairperson.

21 “(2) VACANCY.—In the event that a chair-
 22 person is not appointed within the time frame re-
 23 quired under paragraph (1), the Deputy Adminis-
 24 trator of the Small Business Administration shall
 25 serve as acting chairperson of the Interagency Com-

1 mittee until a chairperson is appointed under para-
2 graph (1).”; and

3 (3) in section 404 (15 U.S.C. 7104)—

4 (A) in the matter preceding paragraph (1),
5 by striking “1995” and inserting “2020”;

6 (B) in paragraph (1), by adding “and” at
7 the end;

8 (C) in paragraph (2), by striking “; and”
9 and inserting a period; and

10 (D) by striking paragraph (3).
