### AN ACT

To provide regulatory relief to charitable organizations that provide housing assistance, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Building Up Inde-
- 3 pendent Lives and Dreams Act" or the "BUILD Act".
- 4 SEC. 2. MORTGAGE LOAN TRANSACTION DISCLOSURE RE-
- 5 QUIREMENTS.
- 6 (a) TILA AMENDMENT.—Section 105 of the Truth
- 7 in Lending Act (15 U.S.C. 1604) is amended by inserting
- 8 after subsection (d) the following:
- 9 "(e) Disclosure for Charitable Mortgage
- 10 Loan Transactions.—With respect to a mortgage loan
- 11 transaction involving a residential mortgage loan offered
- 12 at 0 percent interest with only bonafide and reasonable
- 13 fees and that is primarily for charitable purposes by an
- 14 organization described in section 501(c)(3) of the Internal
- 15 Revenue Code of 1986 and exempt from taxation under
- 16 section 501(a) of such Code, forms HUD-1 and GFE (as
- 17 defined under section 1024.2(b) of title 12, Code of Fed-
- 18 eral Regulations) together with a disclosure substantially
- 19 in the form of the Loan Model Form H-2 (as depicted
- 20 in Appendix H to part 1026 of title 12, Code of Federal
- 21 Regulations) shall, collectively, be an appropriate model
- 22 form for purposes of subsection (b) of this section.".
- 23 (b) RESPA AMENDMENT.—Section 4 of the Real Es-
- 24 tate Settlement Procedures Act of 1974 (12 U.S.C. 2603)
- 25 is amended by adding at the end the following:

- 1 "(d) Disclosure for Charitable Mortgage
- 2 Loan Transactions.—With respect to a mortgage loan
- 3 transaction involving a residential mortgage loan offered
- 4 at 0 percent interest with only bonafide and reasonable
- 5 fees and that is primarily for charitable purposes, an orga-
- 6 nization described in section 501(c)(3) of the Internal
- 7 Revenue Code of 1986 and exempt from taxation under
- 8 section 501(a) of such Code may use forms HUD-1 and
- 9 GFE (as defined under section 1024.2(b) of title 12, Code
- 10 of Federal Regulations) together with a disclosure sub-
- 11 stantially in the form of the Loan Model Form H-2 (as
- 12 depicted in Appendix H to part 1026 of title 12, Code
- 13 of Federal Regulations), collectively, in lieu of the disclo-
- 14 sure published under subsection (a) of this section.".
- 15 (c) Effective Date.—The amendments made by
- 16 subsections (a) and (b) shall take effect on the date of
- 17 the enactment of this Act.
