To repeal section 692 of the Post-Katrina Emergency
Management Reform Act of 2006.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL.**

4 Section 692 of the Post-Katrina Emergency Manage-
5 ment Reform Act of 2006 (6 U.S.C. 792) is repealed.

1 **SEC. 2. NOTIFICATION REQUIREMENTS RELATED TO MODI-**
 2 **FICATIONS TO THE ORDER OF SUCCESSION**
 3 **IN THE DEPARTMENT OF HOMELAND SECU-**
 4 **RITY OR DELEGATIONS OF THE DEPUTY SEC-**
 5 **RETARY.**

6 *Section 103(g)(3) of the Homeland Security Act of*
 7 *2002 (6 U.S.C. 113(g)(3)) is amended to read as follows:*

8 *“(3) NOTIFICATION REQUIREMENTS.—*

9 *“(A) VACANCIES.—The Secretary shall no-*
 10 *tify the Committee on Homeland Security and*
 11 *Governmental Affairs of the Senate and the*
 12 *Committee on Homeland Security of the House*
 13 *of Representatives of any vacancies that require*
 14 *notification under sections 3345 through 3349d*
 15 *of title 5, United States Code (commonly known*
 16 *as the ‘Federal Vacancies Reform Act of 1998’).*

17 *“(B) REVISIONS TO ORDER OF SUCCES-*
 18 *SION.—The Secretary shall submit written noti-*
 19 *fication to the committees referred to in subpara-*
 20 *graph (A) not later than 3 days after—*

21 *“(i) making any modification to the*
 22 *order of succession pursuant to paragraph*
 23 *(2); or*

24 *“(ii) making any modification to*
 25 *Annex B of DHS Delegation 0106, which*
 26 *sets forth the order of succession for the*

1 *Deputy Secretary of Homeland Security, to*
2 *the Delegation to the Senior Official Per-*
3 *forming the Duties of the Deputy Secretary,*
4 *or to any successor document.”.*
