Mr. CORNYN (for himself, Ms. SINEMA, Mr. CRUZ, and Mr. TESTER) introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

A BILL

To designate the Rocksprings Station of the U.S. Border Patrol located on West Main Street in Rocksprings, Texas, as the “Donna M. Doss Border Patrol Station”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Donna M. Doss Memo-
5 rial Act of 2020”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) A native of the State of Washington, Agent
9 Donna Marie Doss—

1 (A) proudly and honorably served her
2 country as an Agent of the U.S. Border Patrol
3 for more than 15 years;

4 (B) began her service with the U.S. Border
5 Patrol in 2003; and

6 (C) graduated as part of the 569th Session
7 of the Border Patrol Academy with Class 584
8 on June 6, 2005.

9 (2) Agent Doss—

10 (A) served on a Drug Enforcement Admin-
11 istration Task Force on the southern border for
12 3 years before being assigned to the northern
13 border;

14 (B) was promoted to Supervisory Border
15 Patrol Agent in Laredo Border Patrol Sector,
16 where she was named an Operations Officer in
17 2016; and

18 (C) relocated to Abilene, Texas in 2017,
19 where she served as a Resident Agent.

20 (3) On February 2, 2019, Agent Doss re-
21 sponded to a call for assistance from the Texas De-
22 partment of Public Safety near Interstate 20 in Tye,
23 Texas. While on scene, Agent Doss was struck and
24 killed by a passing vehicle.

1 (4) Agent Doss is survived by her husband, fa-
2 ther, mother, 2 stepchildren, a sister and a brother.

3 **SEC. 3. DESIGNATION.**

4 The Rocksprings station of the U.S. Border Patrol
5 located on West Main Street in Rocksprings, Texas, shall
6 be known and designated as the “Donna M. Doss Border
7 Patrol Station”.

8 **SEC. 4. REFERENCES.**

9 Any reference in a law, map, regulation, document,
10 paper, or other record of the United States to the station
11 described in section 3 shall be deemed to be a reference
12 to the “Donna M. Doss Border Patrol Station”.
