Ms. COLLINS (for herself and Mr. CARDIN) introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To provide payments for home health services furnished via visual or audio telecommunication systems during an emergency period.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Home Health Emer-
5 gency Access to Telehealth Act” or the “HEAT Act”.

6 **SEC. 2. AUTHORIZATION OF PAYMENTS FOR HOME HEALTH**
7 **SERVICES FURNISHED VIA VISUAL OR AUDIO**
8 **TELECOMMUNICATION SYSTEMS DURING AN**
9 **EMERGENCY PERIOD.**

10 (a) WAIVER AUTHORITY.—

1 (1) IN GENERAL.—The first sentence of section
 2 1135(b) of the Social Security Act (42 U.S.C.
 3 1320b–5(b)) is amended—

4 (A) in paragraph (7), by striking “and” at
 5 the end;

6 (B) in paragraph (8), by striking the pe-
 7 riod at the end and inserting “; and”; and

8 (C) by adding the following new para-
 9 graph:

10 “(9) in the case of home health services fur-
 11 nished in an emergency area (or portion of such an
 12 area) during any portion of any emergency period
 13 (as those terms are defined in subsection (g)(1)(C)),
 14 the provisions of subparagraphs (A) and (B) of sec-
 15 tion 1895(e)(1), as determined appropriate by the
 16 Secretary.”.

17 (2) DEFINITIONS OF EMERGENCY AREA; EMER-
 18 GENCY PERIOD.—Section 1135(g)(1) of the Social
 19 Security Act (42 U.S.C. 1320b–5(g)(1)) is amend-
 20 ed—

21 (A) in subparagraph (A), by striking “sub-
 22 paragraph (B)” and inserting “subparagraphs
 23 (B) and (C)”; and

24 (B) by adding at the end the following new
 25 subparagraph:

1 “(C) ADDITIONAL EXCEPTION.—For pur-
 2 poses of subsection (b)(9), an ‘emergency area’
 3 is a geographical area in which, and an ‘emer-
 4 gency period’ is the period during which, there
 5 exists a public health emergency declared by the
 6 Secretary pursuant to section 319 of the Public
 7 Health Service Act.”.

8 (b) AUTHORIZATION.—Section 1895(e) of the Social
 9 Security Act (42 U.S.C. 1395fff(e)) is amended—

10 (1) in paragraph (1), by striking “Nothing”
 11 and inserting “Subject to paragraph (2), nothing”;

12 (2) by redesignating paragraph (2) as para-
 13 graph (3); and

14 (3) by inserting after paragraph (1) the fol-
 15 lowing new paragraph:

16 “(2) EXCEPTION FOR PUBLIC HEALTH EMER-
 17 GENCIES.—Nothing in this section shall be con-
 18 strued as preventing a home health agency fur-
 19 nishing a home health unit of service for which pay-
 20 ment is made under the prospective payment system
 21 established by this section for such units of service
 22 from furnishing services via a video or audio tele-
 23 communication system if such services—

24 “(A) are furnished pursuant to a waiver
 25 under section 1135(b)(9);

1 “(B) constitute no more than 50 percent of
2 the number of billable visits, consistent with the
3 in-person visit equivalency determination, billed
4 under the 30-day period of care established
5 under section 484.215(f) of title 42, Code of
6 Federal Regulations;

7 “(C) are furnished to a beneficiary under
8 a plan of care established by a physician or
9 practitioner with whom the beneficiary has an
10 existing care relationship prior to the receipt of
11 home health services that includes home health
12 services to be furnished via a video or audio
13 telecommunication system; and

14 “(D) such beneficiary consents to receiving
15 home health services via a video or audio tele-
16 communication system.”.

17 (c) IMPLEMENTATION.—

18 (1) IN GENERAL.—The Secretary shall pre-
19 scribe regulations to apply to home health services
20 furnished pursuant to the amendments made by this
21 Act, which shall become effective no later than 60
22 days after the date of enactment of this Act. The
23 Secretary shall issue an interim final rule, if nec-
24 essary, to comply with the required effective date.

1 (2) CONSIDERATIONS.—In prescribing such reg-
2 ulations, the Secretary may consider including—

3 (A) standards for the content of orders
4 and patient consent for such services;

5 (B) documentation of such services pro-
6 vided and billing units of such services;

7 (C) the nature and level of resources uti-
8 lized for such services provided via video or
9 audio telecommunication systems for purposes
10 of determining equivalency with in-person visits
11 in establishing the payment for such services;
12 and

13 (D) standards to ensure program integrity
14 and prevent the incidence of fraud, waste, and
15 abuse with respect to such services.
