A BILL

To clarify certain provisions of Public Law 103–116, the Catawba Indian Tribe of South Carolina Land Claims Settlement Act of 1993, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. GAMING FACILITY AUTHORIZED.**

2 (a) **GAMING FACILITY AUTHORIZED.**—The Catawba
 3 Indian Nation (formerly the Catawba Indian Tribe of
 4 South Carolina) is authorized to own and operate a gam-
 5 ing facility on the land described in section 2 of this Act,
 6 in Cleveland County, North Carolina.

7 (b) **INDIAN GAMING REGULATORY ACT.**—The facility
 8 described in subsection (a) shall operate in accordance
 9 with the Indian Gaming Regulatory Act (25 U.S.C. 2701
 10 et seq.); except that section 20 of the Indian Gaming Reg-
 11 ulatory Act (25 U.S.C. 2719) shall not apply to the land
 12 described in section 2.

13 (c) **LAND IN TRUST.**—The Secretary of the Interior
 14 is hereby authorized to take the land described in section
 15 2 into trust for the purpose of conducting gaming, on be-
 16 half of the Catawba Indian Nation.

17 (d) **RIGHTS PRESERVED.**—Except as otherwise ex-
 18 pressly provided in this Act, nothing in this Act shall pre-
 19 vent any party from enforcing all rights, privileges, or pro-
 20 hibitions as contained within the Catawba Indian Tribe
 21 of South Carolina Land Claims Settlement Act of 1993
 22 (Public Law 103–116).

23 **SEC. 2. LEGAL DESCRIPTION OF LAND.**

24 The land subject to this Act is described as follows:
 25 Real property in Cleveland County, North Carolina, begin-
 26 ning on a concrete right of way monument having NAD83

1 NC State Plane Grid Coordinates N: 536550.60 USFT
 2 and E: 1292093.25 USFT and being located N 11-18-
 3 59 W 637.68' (Horizontal Ground Distance) from NCGS
 4 "Dixon" having NAD83 NC State Plane Grid Coordinates
 5 N: 535925.42 USFT and E: 1292218.36 USFT; running
 6 thence S 35-20-37 W 83.44' to a concrete right of way
 7 monument; thence along an arc of curve to the left having
 8 a radius of 906.51', an arc length of 357.87', a chord
 9 bearing S 68-52-34 W and a chord length of 355.55' to
 10 a 5/8" Rebar Set; thence S 57-19-29 W 498.70' to a 5/
 11 8" Rebar Set; thence along an arc of curve to the right
 12 having a radius of 1344.39', an arc length of 113.61', a
 13 chord bearing S 59-44-45 W and a chord length of
 14 113.58' to a 5/8" Rebar Set; thence a new line N 23-
 15 34-25 W 751.26' to a 5/8" Rebar Set; thence a new line
 16 N 66-25-35 E 1026.64' to a 5/8" Rebar Set in the West-
 17 ern Right of Way Line of State Project 8.2800802; thence
 18 with the western right of way line N 66-25-35 E 43.71'
 19 to a 5/8" Rebar Set; thence S 23-18-33 E 151.15' to
 20 a 1/2" Rebar Found; thence S 23-18-33 E 93.85' to a
 21 5/8" Rebar Set; thence S 67-29-04 W 19.83' to a 5/8"
 22 Rebar Set; thence S 23-18-56 E 237.04' to a 5/8" Rebar
 23 Set; thence S 17-18-46 E 150.51' to the point and place
 24 of beginning and containing 16.573 Acres +/- and shown
 25 as Lot 1 according to a survey by TGS Engineers dated

1 September 17, 2018. The above described lot contains a
 2 portion of the land described in DB 1210 PG 167 Tract
 3 H, DB 1210 PG 174 Tract H and DB 1210 PG 174
 4 Tract III as owned by Roadside Truck Plaza, Inc.

5 **SECTION 1. SHORT TITLE.**

6 *This Act may be cited as the “Catawba Indian Nation*
 7 *Lands Act”.*

8 **SEC. 2. APPLICATION OF CURRENT LAW.**

9 *(a) LAND IN SOUTH CAROLINA.—Section 14 of the Ca-*
 10 *tawba Indian Tribe of South Carolina Claims Settlement*
 11 *Act of 1993 (Public Law 103–116; 107 Stat. 1136) shall*
 12 *only apply to gaming conducted by the Catawba Indian*
 13 *Nation on land located in the State of South Carolina.*

14 *(b) LAND IN STATES OTHER THAN SOUTH CARO-*
 15 *LINA.—Gaming conducted by the Catawba Indian Nation*
 16 *on land located in States other than the State of South*
 17 *Carolina shall be subject to—*

18 *(1) the Indian Gaming Regulatory Act (25*
 19 *U.S.C. 2701 et seq.); and*

20 *(2) sections 1166 through 1168 of title 18,*
 21 *United States Code.*

22 **SEC. 3. REAFFIRMATION OF STATUS AND ACTIONS.**

23 *(a) RATIFICATION OF TRUST STATUS.—The action*
 24 *taken by the Secretary of the Interior on July 10, 2020,*
 25 *to place approximately 17 acres of land located in Cleve-*

1 *land County, North Carolina, into trust for the benefit of*
2 *the Catawba Indian Nation is hereby ratified and con-*
3 *firmed as if that action had been taken under a Federal*
4 *law specifically authorizing or directing that action.*

5 **(b) ADMINISTRATION.**—*The land placed into trust for*
6 *the benefit of the Catawba Indian Nation by the Secretary*
7 *of the Interior on July 10, 2020, shall be—*

8 **(1)** *part of the Catawba Reservation and admin-*
9 *istered in accordance with the laws and regulations*
10 *generally applicable to land held in trust by the*
11 *United States for the benefit of an Indian Tribe; and*

12 **(2)** *deemed to have been acquired and taken into*
13 *trust as part of the restoration of land for an Indian*
14 *Tribe that is restored to Federal recognition pursuant*
15 *to section 20(b)(1)(B)(iii) of the Indian Gaming Reg-*
16 *ulatory Act (25 U.S.C. 2719(b)(1)(B)(iii)).*

17 **(c) EFFECT.**—*Nothing in this Act shall—*

18 **(1)** *enlarge, impair, or otherwise affect any right*
19 *or claim of the Catawba Indian Nation to any land*
20 *or interest in land in existence before the date of en-*
21 *actment of this Act;*

22 **(2)** *affect any water right of the Catawba Indian*
23 *Nation in existence before the date of enactment of*
24 *this Act;*

1 (3) *terminate or limit any access in any way to*
2 *any right-of-way or right-of-use issued, granted, or*
3 *permitted before the date of enactment of this Act; or*

4 (4) *alter or diminish the right of the Catawba*
5 *Indian Nation to seek to have additional land taken*
6 *into trust by the United States for the benefit of the*
7 *Catawba Indian Nation.*
