A BILL

To provide for a permanent extension of the enforcement instruction on supervision requirements for outpatient therapeutic services in critical access and small rural hospitals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Hospital Regu-
5 latory Relief Act of 2019”.

1 **SEC. 2. PERMANENT EXTENSION OF ENFORCEMENT IN-**
2 **STRUCTION ON SUPERVISION REQUIRE-**
3 **MENTS FOR OUTPATIENT THERAPEUTIC**
4 **SERVICES IN CRITICAL ACCESS AND SMALL**
5 **RURAL HOSPITALS.**

6 Section 1834 of the Social Security Act (42 U.S.C.
7 1395m) is amended by adding at the end the following
8 new subsection:

9 “(x) PERMANENT EXTENSION OF ENFORCEMENT IN-
10 STRUCTION ON SUPERVISION REQUIREMENTS FOR OUT-
11 PATIENT THERAPEUTIC SERVICES IN CRITICAL ACCESS
12 AND SMALL RURAL HOSPITALS.—On and after the date
13 of the enactment of this subsection, the Secretary shall
14 continue to apply the enforcement instruction described in
15 the notice of the Centers for Medicare & Medicaid Services
16 entitled ‘Enforcement Instruction on Supervision Require-
17 ments for Outpatient Therapeutic Services in Critical Ac-
18 cess and Small Rural Hospitals for CY 2013’, dated No-
19 vember 1, 2012 (providing for an exception to the restate-
20 ment and clarification under the final rulemaking changes
21 to the Medicare hospital outpatient prospective payment
22 system and calendar year 2009 payment rates (published
23 in the Federal Register on November 18, 2008, 73 Fed.
24 Reg. 68702 through 68704) with respect to requirements
25 for direct supervision by physicians for therapeutic hos-
26 pital outpatient services), and extended by section 1 of

1 Public Law 113–198, section 1 of Public Law 114–112,
2 section 16004(a) of the 21st Century Cures Act (Public
3 Law 114–255), and section 51007 of the Bipartisan
4 Budget Act (Public Law 115–123), and reinstated for cal-
5 endar years 2018 and 2019 under the final rule entitled
6 ‘Medicare Program: Hospital Outpatient Prospective Pay-
7 ment and Ambulatory Surgical Center Payment Systems
8 and Quality Reporting Programs’ published on December
9 14, 2017 (82 Fed. Reg. 59216).”.
