A BILL

To prohibit Federal funding to entities that do not certify the entities will not perform, or provide any funding to any other entity that performs, an abortion.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Life and
5 Taxpayers Act of 2021”.

6 **SEC. 2. PROHIBITION ON ABORTION.**

7 (a) PROHIBITION.—No Federal funds may be pro-
8 vided (directly or indirectly, including through contract or

1 subcontract) to an entity unless the entity certifies that,
 2 during the period for which such funds are provided, the
 3 entity will not perform, and will not provide any funds
 4 to any other entity that performs, an abortion.

5 (b) EXCEPTION.—Subsection (a) does not apply with
 6 respect to an abortion where—

7 (1) the pregnancy is the result of rape or in-
 8 cest; or

9 (2) a physician certifies that the woman suffers
 10 from a physical disorder, physical injury, or physical
 11 illness that would place the woman in danger of
 12 death unless an abortion is performed, including a
 13 life-threatening physical condition caused by, or aris-
 14 ing from, the pregnancy itself.

15 (c) HOSPITALS.—Subsection (a) does not apply with
 16 respect to a hospital, so long as such hospital does not,
 17 during the period for which funds described in subsection
 18 (a) are provided to such hospital, provide funds to any
 19 non-hospital entity that performs an abortion (other than
 20 an abortion described in subsection (b)).

21 (d) DEFINITIONS.—In this section:

22 (1) The term “entity” means the entire legal
 23 entity, including any entity that controls, is con-
 24 trolled by, or is under common control with, such
 25 entity.

1 (2) The term “hospital” has the meaning given
2 such term in section 1861(e) of the Social Security
3 Act (42 U.S.C. 1395x(e)).
