## A BILL

To amend the American Rescue Plan Act of 2021 to increase appropriations to Restaurant Revitalization Fund, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Continuing Emergency  
5 Support for Restaurants Act”.

1 **SEC. 2. APPROPRIATIONS FOR THE RESTAURANT REVITAL-**  
2 **IZATION FUND.**

3 (a) IN GENERAL.—Section 5003(b)(2) of the Amer-  
4 ican Rescue Plan Act of 2021 (15 U.S.C. 9009c(b)(2))  
5 is amended—

6 (1) in subparagraph (A)—

7 (A) by striking “\$28,600,000,000” and in-  
8 serting “\$76,600,000,000”; and

9 (B) by inserting “, of which \$280,000,000  
10 shall be for administrative expenses to carry out  
11 this section and \$20,000,000 shall be for the  
12 Inspector General of the Small Business Ad-  
13 ministration for audits of grants under this sec-  
14 tion to investigate fraud and to identify ineli-  
15 gible recipients, and for other necessary ex-  
16 penses of the Office of the Inspector General”  
17 before the period at the end; and

18 (2) in subparagraph (B)(i)(II), by striking  
19 “\$23,600,000,000” and inserting  
20 “\$71,300,000,000”.

21 (b) EMERGENCY DESIGNATION.—

22 (1) IN GENERAL.—The amounts provided under  
23 the amendments made by subsection (a) are des-  
24 ignated as an emergency requirement pursuant to  
25 section 4(g) of the Statutory Pay-As-You-Go Act of  
26 2010 (2 U.S.C. 933(g)).

1           (2) DESIGNATION IN SENATE.—In the Senate,  
2           the amendments made by subsection (a) are des-  
3           ignated as an emergency requirement pursuant to  
4           section 4112(a) of H. Con. Res. 71 (115th Con-  
5           gress), the concurrent resolution on the budget for  
6           fiscal year 2018.
