Ms. BALDWIN (for herself and Mr. GRASSLEY) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To amend the Agricultural Foreign Investment Disclosure Act of 1978 to require additional reporting and public disclosure of information.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Farmland Security Act
5 of 2022”.

1 **SEC. 2. REPORTS AND PUBLIC AVAILABILITY OF INFORMA-**
 2 **TION ON FOREIGN INVESTMENT IN AGRICUL-**
 3 **TURAL LAND.**

4 (a) REPORTS.—Section 6 of the Agricultural Foreign
 5 Investment Disclosure Act of 1978 (7 U.S.C. 3505) is
 6 amended—

7 (1) by striking the section designation and
 8 heading and all that follows through “Not later
 9 than” and inserting the following:

10 **“SEC. 6. REPORTS.**

11 “(a) TO STATES.—Not later than”; and

12 (2) by adding at the end the following:

13 “(b) TO CONGRESS.—Not later than 180 days after
 14 the date of enactment of this subsection, and annually
 15 thereafter, the Secretary shall submit to Congress a report
 16 on foreign investments in agricultural land in the United
 17 States, including a description of the impact that foreign
 18 ownership of agricultural land has on family farms, rural
 19 communities, and the domestic food supply.”.

20 (b) PUBLIC AVAILABILITY OF INFORMATION.—Sec-
 21 tion 7 of the Agricultural Foreign Investment Disclosure
 22 Act of 1978 (7 U.S.C. 3506) is amended to read as fol-
 23 lows:

24 **“SEC. 7. PUBLIC DATABASE.**

25 “(a) IN GENERAL.—Not later than 180 days after
 26 the date of enactment of the Farmland Security Act of

1 2022, the Secretary shall establish, and make publicly
2 available on the Department of Agriculture website, a
3 database that—

4 “(1) contains data from each report submitted
5 to the Secretary under section 2 in the preceding
6 calendar year; and

7 “(2) not later than 10 days after the submis-
8 sion of any report under section 2, shall be updated
9 with the data in that report.

10 “(b) DATABASE ORGANIZATION.—The database de-
11 scribed in paragraph (1) shall organize information into
12 the following categories with respect to a foreign person
13 who has submitted a report under section 2:

14 “(1) If the foreign person is an individual, the
15 citizenship of the foreign person.

16 “(2) If the foreign person is not an individual
17 or a government—

18 “(A) the nature of the legal entity that is
19 the foreign person;

20 “(B) the country in which the foreign per-
21 son is registered or organized; and

22 “(C) the principal place of business of the
23 foreign person.”.
