Mr. SANDERS introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To amend the Federal Land Policy and Management Act of 1976 to authorize certain construction activities on public lands, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NURSERIES.**

4 Title VI of the Federal Land Policy and Management
5 Act of 1976 (43 U.S.C. 1781 et seq.) is amended by add-
6 ing at the end the following:

7 **“SEC. 604. NURSERIES.**

8 “(a) IN GENERAL.—Using funds made available
9 under section 40804(b)(8) of the Infrastructure Invest-
10 ment and Jobs Act (16 U.S.C. 6592a(b)(8))—

1 “(1) the Secretary shall carry out a pilot pro-
2 gram to establish and operate nurseries on public
3 lands and other Federal land under the jurisdiction
4 of the Secretary; and

5 “(2) the Secretary of Agriculture, acting
6 through the Chief of the Forest Service, shall carry
7 out a pilot program to establish and operate nurs-
8 eries on National Forest System land.

9 “(b) LOCATIONS.—

10 “(1) DEPARTMENT OF THE INTERIOR.—The
11 Secretary shall carry out the pilot program estab-
12 lished under subsection (a)(1) in—

13 “(A) 4 of the eleven contiguous Western
14 States; and

15 “(B) 1 State that is not 1 of the eleven
16 contiguous Western States.

17 “(2) FOREST SERVICE.—The Secretary of Agri-
18 culture, acting through the Chief of the Forest Serv-
19 ice, shall carry out the pilot program established
20 under subsection (a)(2) in—

21 “(A) 4 of the eleven contiguous Western
22 States; and

23 “(B) 1 State, including the State of
24 Vermont, that is not 1 of the eleven contiguous
25 Western States.

1 “(c) ACTIVITIES.—

2 “(1) DEFINITION OF SECRETARY CON-
3 CERNED.—In this subsection, the term ‘Secretary
4 concerned’ means—

5 “(A) the Secretary, with respect to public
6 lands and other Federal land under the juris-
7 diction of the Secretary; and

8 “(B) the Secretary of Agriculture, acting
9 through the Chief of the Forest Service, with
10 respect to National Forest System land.

11 “(2) AUTHORIZATIONS.—In carrying out a pilot
12 program established under subsection (a), the Sec-
13 retary concerned may—

14 “(A) establish a tree nursery on Federal
15 land under the jurisdiction of the Secretary
16 concerned, and develop the infrastructure nec-
17 essary to support that nursery, to address Fed-
18 eral and regional conservation tree planting
19 needs, consistent with the Bureau of Land
20 Management National Seed Strategy;

21 “(B) purchase necessary equipment and
22 machinery and construct the necessary facilities
23 on Federal land under the jurisdiction of the
24 Secretary concerned to store material, equip-

1 ment, and machinery authorized under this sec-
2 tion;

3 “(C) enter into cooperative agreements
4 with non-Federal entities to use trees produced
5 in nurseries established under the pilot pro-
6 gram;

7 “(D) conduct necessary research on graz-
8 ing and forest management on Federal land
9 under the jurisdiction of the Secretary con-
10 cerned, ensuring the long-term sustainability of
11 such grazing and forest management, to maxi-
12 mize the ability—

13 “(i) to sequester carbon;

14 “(ii) to prevent soil erosion; and

15 “(iii) to improve air and water qual-
16 ity; and

17 “(E) hire and train personnel to carry out
18 the activities described in this section.”.
