A BILL

To require a determination of whether certain Chinese entities are responsible for human rights abuses that meet the criteria for the imposition of sanctions under the Global Magnitsky Human Rights Accountability Act or the Uyghur Human Rights Policy Act of 2020.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Uyghur Human Rights
5 Sanctions Review Act”.

1 **SEC. 2. DETERMINATION OF WHETHER ACTIONS OF CER-**
2 **TAIN CHINESE ENTITIES MEET CRITERIA FOR**
3 **IMPOSITION OF SANCTIONS.**

4 (a) IN GENERAL.—Not later than 30 days after the
5 date of the enactment of this Act, the Secretary of the
6 Treasury, in consultation with the Secretary of State and
7 the Attorney General, shall—

8 (1) determine whether any entity specified in
9 subsection (b)—

10 (A) is responsible for or complicit in, or
11 has directly or indirectly engaged in, serious
12 human rights abuses against Uyghurs or other
13 predominantly Muslim ethnic groups in the
14 Xinjiang Uyghur Autonomous Region of the
15 People’s Republic of China; and

16 (B) meets the criteria for the imposition of
17 sanctions under—

18 (i) the Global Magnitsky Human
19 Rights Accountability Act (22 U.S.C.
20 10101 et seq.);

21 (ii) section 6 of the Uyghur Human
22 Rights Policy Act of 2020 (Public Law
23 116–145; 22 U.S.C. 6901 note); or

24 (iii) Executive Order 13818 (50
25 U.S.C. 1701 note; relating to blocking the
26 property of persons involved in serious

1 human rights abuse or corruption), as
2 amended on or after the date of the enact-
3 ment of this Act; and

4 (2) submit to Congress a report on that deter-
5 mination that includes the reasons for the deter-
6 mination.

7 (b) ENTITIES SPECIFIED.—An entity specified in this
8 subsection is any of the following:

9 (1) Hangzhou Hikvision Digital Technology
10 Co., Ltd.

11 (2) Shenzhen Huada Gene Technology Co.,
12 Ltd. (BGI Group).

13 (3) Tiandy Technologies Co., Ltd.

14 (4) Zhejiang Dahua Technology Co., Ltd.
