To amend title 5, United States Code, to provide for the halt in pension payments for Members of Congress sentenced for certain offenses, and for other purposes.

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "No Congressionally
- 3 Obligated Recurring Revenue Used as Pensions To Incar-
- 4 cerated Officials Now Act" or the "No CORRUPTION
- 5 Act".

#### 6 SEC. 2. FORFEITURE OF PENSION.

- 7 (a) IN GENERAL.—Section 8332(o) of title 5, United
- 8 States Code, is amended—
- 9 (1) by redesignating paragraphs (4), (5), and
- 10 (6) as paragraphs (5), (6), and (7), respectively;
- 11 (2) by inserting after paragraph (3) the fol-
- lowing:
- 13 "(4)(A) Subject to subparagraph (B), an individual
- 14 convicted of an offense described in paragraph (2) shall
- 15 not be eligible to receive any payment of an annuity pursu-
- 16 ant to the retirement system under this subchapter or
- 17 chapter 84, except that this sentence applies only to such
- 18 payments based on service rendered as a Member (irre-
- 19 spective of when rendered).
- 20 "(B) If the conviction of an individual described in
- 21 subparagraph (A) is overturned on appeal by a court of
- 22 competent jurisdiction, the individual shall receive pay-
- 23 ments that the individual would have received but for the
- 24 application of subparagraph (A).
- 25 "(C) This paragraph applies only to a conviction that
- 26 occurs after the date of enactment of the No Congression-

- 1 ally Obligated Recurring Revenue Used as Pensions To
- 2 Incarcerated Officials Now Act.";
- 3 (3) in paragraph (5)(B)(i), as so redesignated,
- 4 by striking "paragraph (5)" and inserting "para-
- 5 graph (6)"; and
- 6 (4) in paragraph (6), as so redesignated, by
- 7 striking "paragraph (4)(B)" and inserting "para-
- 8 graph (5)(B)".
- 9 (b) Technical and Conforming Amendment.—
- 10 Section 719(e)(2) of title 38, United States Code, is
- 11 amended by striking "section 8332(o)(5)" and inserting
- 12 "section 8332(o)(6)".
