Ms. MALLIOTAKIS introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To direct the Secretary of State to revoke the visas of students who have engaged in antisemitic activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Visas for Anti-
5 Semitic Students Act”.

6 **SEC. 2. VISA REVOCATION OR DENIAL FOR STUDENTS EN-**
7 **GAGING IN ANTISEMITIC ACTIVITIES.**

8 (a) IN GENERAL.—The Secretary of State shall re-
9 voke or deny a visa under subparagraph (F) or (M) of
10 section 101(a)(15) of the Immigration and Nationality Act

1 (8 U.S.C. 1101(a)(15)) to any alien who, on or after the
2 date of enactment of this Act—

3 (1) engages in prohibited antisemitic conduct;
4 and

5 (2) is determined by the Secretary of State,
6 pursuant to section 237(a)(4)(C)(i) of the Immigra-
7 tion and Nationality Act (8 U.S.C.
8 1227(a)(4)(C)(i)), to pose potentially serious adverse
9 foreign policy consequences for the United States
10 through such conduct.

11 (b) DEFINITIONS.—In this section:

12 (1) ANTISEMITISM.—The term “antisemitism”
13 means the definition adopted on May 26, 2016, by
14 the International Holocaust Remembrance Alliance,
15 of which the United States is a member, as adopted
16 by the Department of State, including the “contem-
17 porary examples of antisemitism” identified therein.

18 (2) PROHIBITED ANTISEMITIC CONDUCT.—The
19 term “prohibited antisemitic conduct” means—

20 (A) engaging in a physical act of violence,
21 vandalism, or harassment targeting a Jewish
22 individual, their property, a community institu-
23 tion, or religious facility, with intent to intimi-
24 date or harm based on based on the Jewish

1 identity or affiliation of the individual or prop-
2 erty targeted; or

3 (B) providing material support (including
4 funding, organizing, or inciting) to a person
5 knowing that the person intended to use such
6 support to engage in an act described in sub-
7 paragraph (A).

8 **SEC. 3. TERMS OF NONIMMIGRANT STATUS FOR STUDENTS.**

9 Section 214 of the Immigration and Nationality Act
10 (8 U.S.C. 1184) is amended by adding at the end the fol-
11 lowing:

12 “(s)(1) An alien may not be granted or maintain non-
13 immigrant status under subparagraph (F) or (M) of sec-
14 tion 101(a)(15) if the alien engages in prohibited
15 antisemitic conduct and the Secretary of State determines,
16 pursuant to section 237(a)(4)(C)(i), that such conduct
17 would have potentially serious adverse foreign policy con-
18 sequences for the United States.

19 “(2) If the Secretary of State determines that an
20 alien who has been granted nonimmigrant status under
21 subparagraph (F) or (M) of section 101(a)(15) has en-
22 gaged in prohibited antisemitic conduct, and that, as de-
23 scribed in section 237(a)(4)(C)(i), such alien or such
24 alien’s conduct poses potentially serious adverse foreign

1 policy consequences for the United States, the Secretary
2 shall revoke the alien's visa.

3 “(3) In this subsection:

4 “(A) The term ‘antisemitism’ means the defini-
5 tion adopted on May 26, 2016, by the International
6 Holocaust Remembrance Alliance, of which the
7 United States is a member, as adopted by the De-
8 partment of State, including the ‘contemporary ex-
9 amples of antisemitism’ identified therein.

10 “(B) The term ‘prohibited antisemitic conduct’
11 means—

12 “(i) engaging in a physical act of violence,
13 vandalism, or harassment targeting a Jewish
14 individual, their property, a community institu-
15 tion, or religious facility, with intent to intimi-
16 date or harm based on based on the Jewish
17 identity or affiliation of the individual or prop-
18 erty targeted; or

19 “(ii) providing material support (including
20 funding, organizing, or inciting) to a person
21 knowing that the person intended to use such
22 support to engage in an act described in clause
23 (i).”.
