A BILL

To require the Director of the National Institute of Standards and Technology to develop resources for small businesses in utilizing artificial intelligence, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Small Business Artifi-*
5 *cial Intelligence Advancement Act”.*

6 **SEC. 2. RESOURCES FOR SMALL BUSINESSES TO UTILIZE**
7 **ARTIFICIAL INTELLIGENCE.**

8 *Section 22A of the National Institute of Standards and*
9 *Technology Act (15 U.S.C. 278h–1) is amended—*

10 *(1) by redesignating subsection (h) as subsection*
11 *(i); and*

12 *(2) by inserting after subsection (g) the following*
13 *new subsection:*

14 *“(h) DEVELOPMENT OF RESOURCES FOR SMALL BUSI-*
15 *NESSES IN UTILIZING ARTIFICIAL INTELLIGENCE.—*

16 *“(1) IN GENERAL.—Subject to the availability of*
17 *appropriations, the Director shall, in carrying out*
18 *subsection (a), develop or identify, and disseminate*
19 *(in accordance with paragraph (4)), resources for*
20 *small business concerns (as such term is defined in*
21 *section 3 of the Small Business Act (15 U.S.C. 632))*
22 *relating to artificial intelligence. Such resources may*
23 *include technical standards, best practices, bench-*
24 *marks, methodologies, procedures, or processes for the*

1 *understanding, adoption, or integration of artificial*
2 *intelligence.*

3 “(2) *REQUIREMENTS.—The Director shall ensure*
4 *that the resources described in paragraph (1) satisfy*
5 *the following:*

6 “(A) *Are generally applicable and usable by*
7 *a wide range of small business concerns.*

8 “(B) *Include elements that promote basic*
9 *understanding, identification, and adoption of*
10 *proper use cases of artificial intelligence.*

11 “(C) *Include case studies of practical appli-*
12 *cation across a range of business sizes and types.*

13 “(D) *Are technology-neutral and relevant to*
14 *technologies that are accessible and suitable for*
15 *small businesses.*

16 “(E) *Are based on international voluntary*
17 *standards as applicable, and are consistent with*
18 *the Stevenson-Wydler Technology Innovation Act*
19 *of 1980 (15 U.S.C. 3701 et seq.).*

20 “(F) *Include recommendations and ref-*
21 *erences to existing Federal educational resources,*
22 *including the risk management framework under*
23 *subsection (c), privacy and cybersecurity risk*
24 *management frameworks established by the Insti-*
25 *tute, and activities relating to the national cy-*

1 *bersecurity awareness and education program*
2 *under section 303 of the Cybersecurity Enhance-*
3 *ment Act of 2014 (15 U.S.C. 7443).*

4 “(3) *REVIEW AND UPDATE OF RESOURCES.*—*Not*
5 *later than two years after the date of the enactment*
6 *of this subsection and not less frequently than once*
7 *every two years thereafter, the Director shall carry*
8 *out the following:*

9 “(A) *Review the resources described in*
10 *paragraph (1).*

11 “(B) *Update such resources as the Director*
12 *considers appropriate.*

13 “(4) *DISSEMINATION AND USE OF TRAINING RE-*
14 *SOURCES.*—*The Director shall coordinate with the*
15 *Administrator of the Small Business Administration*
16 *regarding the distribution and use through the re-*
17 *source partners of the Small Business Administration*
18 *of the resources described in paragraph (1).*

19 “(5) *VOLUNTARY RESOURCES.*—*The use of the re-*
20 *sources described in paragraph (1) shall be considered*
21 *voluntary.*

22 “(6) *REPORT.*—

23 “(A) *IN GENERAL.*—*Not later than four*
24 *years after the date of the enactment of this sub-*
25 *section, the Director shall submit to the Com-*

1 *mittee on Science, Space, and Technology of the*
2 *House of Representatives and the Committee on*
3 *Commerce, Science, and Transportation of the*
4 *Senate a report on the development, identifica-*
5 *tion, dissemination, and use of the resources de-*
6 *scribed in paragraph (1), including updates*
7 *made pursuant to paragraph (3).*

8 “(B) *CONTENTS.*—*The report under sub-*
9 *paragraph (A) shall include the following:*

10 “(i) *A list of the resources described in*
11 *paragraph (1), including updates made*
12 *pursuant to paragraph (3).*

13 “(ii) *Relevant feedback from recipients*
14 *of such resources, and disseminators of such*
15 *resources pursuant to paragraph (4).*

16 “(iii) *Recommendations to Congress*
17 *for further actions to help with the utiliza-*
18 *tion of artificial intelligence by small busi-*
19 *ness concerns.”.*
