A BILL

To amend the Public Utility Regulatory Policies Act of 1978 to repeal the standard relating to electric vehicle charging programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Guarding Ratepayers
5 from Imposed EV Charging Directives Act” or the “GRID
6 Act”.

1 **SEC. 2. REPEAL OF STANDARD RELATING TO ELECTRIC VE-**
2 **HICLE CHARGING PROGRAMS.**

3 (a) STANDARD.—Paragraph (21) of section 111(d) of
4 the Public Utility Regulatory Policies Act of 1978 (16
5 U.S.C. 2621(d)) is repealed.

6 (b) CONFORMING AMENDMENTS.—

7 (1) TIME LIMITATIONS.—Paragraph (8) of sec-
8 tion 112(b) of the Public Utility Regulatory Policies
9 Act of 1978 (16 U.S.C. 2622(b)) is repealed.

10 (2) FAILURE TO COMPLY.—Section 112(c) of
11 the Public Utility Regulatory Policies Act of 1978
12 (16 U.S.C. 2622(c)) is amended by striking “In the
13 case of the standard established by paragraph (21)
14 of section 111(d), the reference contained in this
15 subsection to the date of enactment of this Act shall
16 be deemed to be a reference to the date of enact-
17 ment of that paragraph (21).”.

18 (3) OTHER PRIOR STATE ACTIONS.—Subsection
19 (h) of section 112 of the Public Utility Regulatory
20 Policies Act of 1978 (16 U.S.C. 2622) is repealed.

21 (4) PRIOR AND PENDING PROCEEDINGS.—Sec-
22 tion 124 of the Public Utility Regulatory Policies
23 Act of 1978 (16 U.S.C. 2634) is amended by strik-
24 ing “In the case of the standard established by para-
25 graph (21) of section 111(d), the reference con-
26 tained in this section to the date of enactment of

- 1 this Act shall be deemed to be a reference to the
- 2 date of enactment of that paragraph (21).”.
