## A BILL

To require the establishment and publication of procedures relating to the disposal of residual inventory upon the termination or completion of programs, projects, or activities of the Department of State and the United States Agency for International Development, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Strengthening Uniform  
3 Procedures to Prevent the Loss, Incineration, and Expira-  
4 tion of Supplies Act” or the “SUPPLIES Act”.

5 **SEC. 2. RESIDUAL SUPPLIES.**

6 (a) PROCEDURES REQUIRED.—Not later than 60  
7 days after the date of the enactment of this Act, the Sec-  
8 retary of State and the Administrator of the United States  
9 Agency for International Development shall establish pro-  
10 cedures on the disposition of residual inventory of unused  
11 supplies or commodities upon the termination or comple-  
12 tion of a project or program. Such procedures shall  
13 prioritize ensuring that such supplies or commodities are  
14 not diverted, destroyed, or otherwise expire without use.

15 (b) PUBLICATION.—The Secretary of State and the  
16 Administrator of the United States Agency for Inter-  
17 national Development shall publish the procedures estab-  
18 lished pursuant to subsection (a) on publicly available  
19 websites of the Department of State and of the United  
20 States Agency for International Development, respectively.

21 (c) COMMODITY DEFINED.—For purposes of this sec-  
22 tion, the term “commodity” means a perishable or non-  
23 perishable commodity or product (including medicine, vac-  
24 cines, medical devices, food, and food commodities) that  
25 is procured, managed, controlled, or held in warehouses,  
26 ships, shipping containers, or any other storage facility,

1 by the United States Government or by a foreign assist-  
2 ance implementing partner of the United States Govern-  
3 ment for the purpose of providing foreign assistance.
