A BILL

To amend title 38, United States Code, to improve the provision of direct housing loans and medical care from the Department of Veterans Affairs for Native Hawaiians.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Parity for Native Ha-
5 waiian Veterans Act of 2025”.

1 **SEC. 2. MODIFICATION TO PROGRAM FOR DIRECT HOUS-**
 2 **ING LOANS MADE TO NATIVE AMERICAN VET-**
 3 **ERANS BY THE SECRETARY OF VETERANS AF-**
 4 **FAIRS.**

5 Section 3765(3)(B) of title 38, United States Code,
 6 is amended by striking “as that term” and all that follows
 7 through “42 Stat. 108)” and inserting “as defined in sec-
 8 tion 801 of the Native American Housing Assistance and
 9 Self-Determination Act of 1996 (25 U.S.C. 4221)”.

10 **SEC. 3. IMPROVEMENT OF PROVISION OF MEDICAL CARE**
 11 **FROM DEPARTMENT OF VETERANS AFFAIRS**
 12 **FOR NATIVE HAWAIIANS.**

13 (a) REIMBURSEMENT OF COSTS OF CERTAIN CARE
 14 PROVIDED THROUGH NATIVE HAWAIIAN HEALTH CARE
 15 SYSTEM.—

16 (1) IN GENERAL.—Subchapter I of chapter 17
 17 of title 38, United States Code, is amended by in-
 18 serting after section 1703G the following new sec-
 19 tion:

20 **“§ 1703H. Reimbursement of costs of certain care pro-**
 21 **vided through Native Hawaiian health**
 22 **care system**

23 “(a) IN GENERAL.—The Secretary shall reimburse a
 24 Native Hawaiian health care system for the costs of care
 25 or services provided through such system to veterans eligi-
 26 ble for such care or services under the laws administered

1 by the Secretary, regardless of whether such care or serv-
 2 ices are provided directly through such system, through
 3 purchased or referred care, or through a contract for trav-
 4 el.

5 “(b) NATIVE HAWAIIAN HEALTH CARE SYSTEM DE-
 6 FINED.—The term ‘Native Hawaiian health care system’
 7 has the meaning given that term in section 12 of the Na-
 8 tive Hawaiian Health Care Improvement Act (42 U.S.C.
 9 11711).”.

10 (2) CLERICAL AMENDMENT.—The table of sec-
 11 tions at the beginning of such chapter is amended
 12 by inserting after the item relating to section 1703G
 13 the following new item:

“1703H. Reimbursement of costs of certain care provided through Native Ha-
 waiian health care system.”.

14 (b) EXEMPTION FROM COST SHARING.—Section
 15 1730A(b) of such title is amended—

16 (1) in paragraph (1), by striking “; or” and in-
 17 serting a semicolon;

18 (2) in paragraph (2), by striking the period at
 19 the end and inserting “; or”; and

20 (3) by adding at the end the following new
 21 paragraph:

1 “(3) is a Native Hawaiian (as defined in section
2 12 of the Native Hawaiian Health Care Improve-
3 ment Act (42 U.S.C. 11711)).”.
