Mr. DAINES (for himself and Mr. HICKENLOOPER) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

## A BILL

To reauthorize the Cooperative Watershed Management Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cooperative Watershed  
5 Management Program Reauthorization Act of 2026”.

6 **SEC. 2. COOPERATIVE WATERSHED MANAGEMENT PRO-**  
7 **GRAM.**

8 (a) DEFINITIONS.—Section 6001 of the Omnibus  
9 Public Land Management Act of 2009 (16 U.S.C. 1015)  
10 is amended—

1           (1) by redesignating paragraphs (4) through  
2           (7) as paragraphs (5) through (8), respectively;

3           (2) by inserting after paragraph (3) the fol-  
4           lowing:

5           “(4) INDIAN TRIBE.—The term ‘Indian tribe’  
6           has the meaning given the term in section 4 of the  
7           Indian Self-Determination and Education Assistance  
8           Act (25 U.S.C. 5304).”;

9           (3) in paragraph (7) (as so redesignated), in  
10          subparagraph (B)(v)—

11           (A) in subclause (I), by striking “or” at  
12          the end;

13           (B) in subclause (II), by inserting “or”  
14          after the semicolon; and

15           (C) by adding at the end the following:

16                           “(III) has ancestral lands within  
17                           the watershed;”.

18          (b) PROGRAM.—Section 6002 of the Omnibus Public  
19          Land Management Act of 2009 (16 U.S.C. 1015a) is  
20          amended—

21           (1) in subsection (c)—

22           (A) in paragraph (1)(B)—

23           (i) in clause (i), by striking “interests;  
24           or” and inserting “interests, including In-  
25           dian tribes;”;

1 (ii) by redesignating clause (ii) as  
2 clause (iii); and

3 (iii) by inserting after clause (i) the  
4 following:

5 “(ii) demonstrate significant need due  
6 to drought, wildfire, or other natural dis-  
7 aster; or”;

8 (B) in paragraph (2)—

9 (i) in subparagraph (A)(i), by striking  
10 “\$100,000” and all that follows through  
11 the period at the end and inserting  
12 “\$150,000 each year for a period of not  
13 less than 3 years, subject to the sufficiency  
14 of applications submitted and the avail-  
15 ability of appropriations.”;

16 (ii) by striking clause (iii);

17 (iii) by redesignating clauses (iv) and  
18 (v) as clauses (iii) and (iv), respectively;  
19 and

20 (iv) by adding at the end the fol-  
21 lowing:

22 “(v) CONTINUATION AND EXTEN-  
23 SION.—

24 “(I) IN GENERAL.—The Sec-  
25 retary may, at the discretion of the

1 Secretary, issue a continuation of the  
 2 first-phase grant for not more than 2  
 3 additional years if the recipient of the  
 4 first-phase grant has demonstrated  
 5 satisfactory performance with imple-  
 6 mentation of the proposal under the  
 7 initial grant, as determined by the  
 8 Secretary.

9 “(II) AMOUNTS.—A grant con-  
 10 tinued pursuant to subclause (I) shall  
 11 be in an amount not greater than  
 12 \$150,000 each year, as determined to  
 13 be appropriate by the Secretary.”;

14 (C) in paragraph (3)(B)(ii), by striking  
 15 “quantity.” and inserting the following: “quan-  
 16 tity, including—

17 “(I) grant writing;

18 “(II) project management; and

19 “(III) technical assistance, such  
 20 as feasibility, design, preliminary envi-  
 21 ronmental review, and engineering.”;

22 and

23 (D) by adding at the end the following:

24 “(4) CONTINUOUS ENROLLMENT.—The Sec-  
 25 retary shall—

1           “(A) make funding opportunities for the  
2           program available on a regular basis; and

3           “(B) allow applications for grants under  
4           the program to be submitted and evaluated  
5           multiple times during a calendar year.”;

6           (2) in subsection (f), in the matter preceding  
7           paragraph (1), by inserting “, and make available to  
8           the public,” after “House of Representatives”; and

9           (3) by striking subsection (g) and inserting the  
10          following:

11          “(g) AUTHORIZATION OF APPROPRIATIONS.—There  
12          is authorized to be appropriated to carry out this section  
13          \$40,000,000 for each of fiscal years 2027 through 2031.”.
